Okay. So, Mr. Lapan, it's 12 my understanding there's an Offer in Compromise. 13 And the Offer in Compromise is that a written 14 warning will be issued. Is this your 15 understanding of the Offer in Compromise, sir? 16 MR. LAPAN: Yes, it is. 17 CHAIRPERSON ANDERSON: Are you aware 18 that by accepting an Offer in Compromise that 19 you're giving up your right to a hearing? 20 MR. LAPAN: Yes, I am. 21 CHAIRPERSON ANDERSON: Are you also 22 aware that by accepting an Offer in Compromise 23 that you're giving up your right to appeal this 24 matter?
