3 CHAIRPERSON ANDERSON: We're back on
4 the record. Good afternoon, everyone, and
5 welcome to the ABC Board. We have our afternoon
6 hearings. Before we get underway, I want to
7 introduce the parties. My name is Donovan
8 Anderson. I'm Chairman of the Board. With us
9 today are five other members of the Board, which
10 is Ms. Rafi Crockett, Mr. Bobby Cato, Ms. Jeni
11 Hansen, Mr. James Short and Mr. Ed Grandis. The
12 Board has six members in participation for this
13 hearing this afternoon and we do have a quorum to
14 conduct business.

15 Before we get underway with this
16 afternoon's hearing calendar, I need to make a
17 few instructions very clear so that the conduct
18 of these hearings is understood by everyone.
19 There are seven scheduled cases on our calendar
20 for the afternoon. Once your case is called, I
21 will take a moment for our IT specialist -- can I
22 ask all Board members to mute their phone,
23 please? Thank you.

24 Once your case is called, I will take
25 a moment for our IT specialist to elevate the

1 rights for each party to enable their camera and
2 microphone. Then and only then will you have the
3 ability to engage your equipment. If your case
4 is not being heard, you will remain mute and your
5 camera will be disabled. At the conclusion of
6 each case, the parties will have the option to
7 leave. If the party chooses to stay, all cameras
8 and microphones for the concluded case will be
9 disabled.
