3 CHAIRPERSON ANDERSON: Let us now do
4 our agenda items. All right, the first agenda
5 that we'll do this morning, it's our legal

1 the required quarterly statement, it's a
2 secondary tier violation, statutory authority,
3 D.C. Code Section 25113B2A. There is a \$500 fine
4 payable within 30 days or the license shall be
5 suspended indefinitely until the fine has been
6 paid. All the terms they should submit, pending
7 quarterly statements if they have not been
8 submitted as of yet.

9 I therefore make a motion that the

7 request cease and desist. This is for Happy Bud,
8 Case Number 24-ULC-00047. Recommendation,

9 one day substantial change. It's a holiday
10 event. The nature of the substantial change,
11 they'll have live music and to have live
