3 MS. FLETCHER: The next case on the
4 calendar is Red Lounge Hookah, case number 22-
5 PRO-00119. Salma, LLC 2013 A 14th Street NW.
6 License number ABRA 076011. This is a Retailer
7 Class CT license renewal. The protest issues are
8 adverse impact on peace, order and quiet.

9 My name is LaVerne Fletcher conducting
10 the Roll Call Hearing as the Board's agent.

11 Is anyone present on behalf of Red
12 Lounge Hookah? Oh, I actually a note for the
13 record related to that question. The Applicant,
14 well first of all, who is present on behalf of
15 ANC 1B?

16 MS. HARRIS: Hi, Ms. Fletcher. This
17 is Commissioner Sabel Harris for 1B.

18 MS. FLETCHER: Ms. Harris, would you
19 spell your name for the record, please?

20 MS. HARRIS: Yes, that is S-A-B as in
21 boy-E-L H-A-R-R-I-S.

22 MS. FLETCHER: Thank you. So, Ms.
23 Harris, the owners of the establishment are not
24 present on Webex, they actually showed up in
25 person this morning at 10:00. So, I'm going to

1 read into the record who was present. I'm going
2 to make an attempt to pronounce this name. It's
3 Amadou Bah, it's spelled A-M-A-D-O-U. The last
4 name is spelled B-A-H. The second person who was
5 present I'm not going to try to pronounce this
6 first name, I'm going to spell it. It's spelled
7 O-U-A-F like Frank-A-E. The last name is Harrag
8 and that's spelled H-A-R-R-A-G.

9 So, Ms. Harris, they were both present
10 this morning. They didn't realize that we don't
11 hold hearings in person right now, but they were
12 here. I'm going to give the date for the status
13 and the protest hearing and then I'll set a date
14 for mediation based on your availability and I
15 will get back with the owners and then I'll get
16 back with you to confirm the date, Ms. Harris.

17 The status hearing is scheduled for
18 March 1st, 2023 at 10:30 a.m. for the status
19 hearing. The protest hearing is scheduled for
20 March 29 at 1:30. Ms. Harris, I'm going to give
21 you the next available date for mediation and you
22 can let me know if you're available. Are you
23 available on Thursday, January 19 between 10:00
24 and 1:30?

25 MS. HARRIS: I do have availability

1 then, preferably ay time after 11:00 a.m.

2 MS. FLETCHER: All right. What about
3 11:30?

4 MS. HARRIS: That works for me and
5 then I don't^I mean I think we can cover this. I
6 would explain that if they of the establishment
7 can't do that, I do have time after that, too,
8 so.

9 MS. FLETCHER: Okay. Well then I will
10 keep you posted. Thank you, Ms. Harris, for
11 coming.

12 MS. HARRIS: Thank you.

13 MS. FLETCHER: The roll call hearing
14 in this matter is concluded.
