ORDER ON COOPERATIVE AGREEMENT

The official records of the Alcoholic Beverage Control Board (Board) reflect that Mission Group Dos, LLC, t/a Mission Dos, Applicant for a new Retailer's Class CT License, located at 1221 Van Street, SE, #130/230, Washington, D.C., and ANC 6D have entered into a Cooperative Agreement (Agreement), dated March 19, 2018, that governs the operation of the Applicant's establishment.

The Agreement has been reduced to writing and has been properly executed and filed with the Board. The Applicant and Chairperson Meredith Fascett and Dr. Coralie Farlee, on behalf of ANC 6D, are signatories to the Agreement.

Accordingly, it is this 28th day of March, 2017, **ORDERED** that:

1. The above-referenced Cooperative Agreement submitted by the parties to govern the operations of the Applicant's establishment is **APPROVED** and **INCORPORATED** as part of this Order, except for the following modifications:

First Whereas paragraph – The language “including Mexican-style food” shall be replaced with the language “hot and cold foods.”


Section 2 (Nature of Business) – The language “Mexican and other food” shall be replaced with the language “hot and cold foods.”

The parties have agreed to these modifications.



COOPERATIVE AGREEMENT

THIS COOPERATIVE AGREEMENT ("Agreement") is made on this 19th day of March 2018 by and between Mission Group Dos, LLC t/a Mission Navy Yard ("Applicant"), at 1221 Van Street, SE, #s 130&230, Washington, DC 20003 ABRA License #108928 and Advisory Neighborhood Commission 6D ("the ANC"), (collectively, the "Parties").

PREAMBLE

Through this agreement both parties aim to create an environment in which the Applicant may operate as a viable contributing establishment in the ANC6D community.

WITNES ETH

WHEREAS, Applicant has applied for a License Class CT for a business establishment ("Establishment") serving spirits, wine, and beer, offering a full restaurant menu, with appetizers, sides, and entrees including Mexican-style food, including indoor space, with entertainment and dancing endorsements; and a sidewalk cafe, and a second floor summer garden located at 1221 Van Street, SE, #s 130 and 230, Washington, D.C. 20003 ("Premises"); and

WHEREAS, the Applicant is encouraged to work regularly with ANC6D and its representatives, other neighborhood organizations, and residents to ensure that the business operations facilitate the enjoyment of the surrounding neighborhood; and

WHEREAS, the Parties are desirous of entering into a Cooperative Agreement pursuant to D.C. Official Code § 25-446 for the operation and maintenance of the Establishment in such a manner as to minimize the effect of the establishment within the ANC on (1) peace, order, and quiet, including the noise and litter provisions set forth in §§ 25-725 and 25-726; and (2) residential parking needs and vehicular and pedestrian safety, and to eliminate the need for a Protest Hearing regarding the license application; and

WHEREAS, all parties believe that the statements and provisions contained in this agreement are reasonable and shall become wholly integrated into the day-to-day operation of the Establishment. The Parties agree that any substantial change in operations is considered of great concern to the community which they may bring to the attention of the ABC Board; and

WHEREAS, the Parties have agreed to enter into this Agreement and request that the Alcoholic Beverage Control Board ("ABC Board") approve the Applicant's license application conditioned upon the Applicant's compliance with the terms of this written Agreement; and

NOW, THEREFORE, in consideration of the recitals set forth above and the mutual covenants and conditions set forth below, the Parties agree as follows:

1. **Recitals Incorporated.** The recitals set forth above are incorporated herein by reference.
2. **Nature of the Business.** The Applicant will manage and operate an Establishment serving spirits, wine, and beer, offering Mexican and other food. The Establishment will have an indoor area consisting of two floors with one sidewalk café (on Van Street, SE) and one second floor summer garden (overlooking South Capital Street, SE and N Street, SE). There shall be no entertainment or dancing in the sidewalk café or summer garden. There may be Entertainment and dancing endorsements in the indoor space, but no cover charge endorsement. Establishment shall not participate in pub crawls. The Establishment shall have no flashing or billboard-type lights or use billboard-type lights to advertise the establishment.

3. **Hours of Operation and Sales.**

The hours of operation of the indoor space shall not exceed:

Sunday through Thursday: 9:00 a.m. - 2:00 a.m.,
Friday and Saturday: 9:00 a.m. - 3:00 a.m.

The hours of sales, service, and consumption in the indoor space shall not exceed:

Sunday through Thursday: 9:00 a.m. - 2:00 a.m.,
Friday and Saturday: 9:00 a.m. - 3:00 a.m.

The hours of live entertainment and dancing indoors shall not exceed:

Sunday 2:00 p.m. - 2:00 a.m.,
Monday - Thursday: 5:00 p.m. - 2:00 a.m.,
Friday and Saturday: 2:00 p.m. - 3:00 a.m.

The hours of operation of and sales, service, and consumption in the ground floor sidewalk café shall not exceed:

Sunday through Thursday: 9:00 a.m. - 12:00 a.m.,
Friday and Saturday: 9:00 a.m. - 2:00 a.m.

The hours of operation of and sales, service, and consumption in the second floor summer garden shall not exceed:

Sunday through Thursday: 9:00 a.m. - 1:00 a.m.,
Friday and Saturday: 9:00 a.m. - 2:00 a.m.

Recorded music shall end in the sidewalk café and summer garden no later than 10:30 p.m. on Sunday through Thursday, and 12:00 a.m. Friday and Saturday.

Provided that: (a) on days designated by the DC ABC Board as "Holiday Extension of Hours" applicant may avail itself of the extended hours so provided; (b) in the event the Council of the District of Columbia or the ABC Board grants licensees in general extended operating hours (such as for Inauguration) applicant may avail itself of such extended hours; and (c) on January 1 of each year applicant may operate until 4:00a.m. The ANC will not object to the Applicant applying for a one-day substantial change to permit operation and consumption of alcoholic beverages in the second floor summer garden (which overlooks South

Capital Street, SE and N Street, SE) and the ground floor sidewalk café (on N Street, SE sidewalk) to 2:00 a.m. on Thursdays or Sundays when Washington Nationals games commence at 7:00 p.m. or later.

Consistent with Alcoholic Beverage Control Board interpretations, "closing hours" shall be construed as the hours at which no patrons shall remain on the premises.

4. **Floors Utilized and Occupancy.** The Applicant will operate its Establishment on the first and second floors, with dance floors on both levels and sidewalk café and second floor summer garden. The Certificate of Occupancy will state the seating and occupant load; however, the Establishment will not exceed a total interior occupancy of 514 guests. The entire first floor will have a maximum occupancy of 126 patrons including a maximum of 24 seated and an additional 16 standing guests in the ground floor sidewalk café. The second floor will have a maximum occupancy of 388 guests, including a maximum of 32 seated and an additional 28 standing guests in the second floor summer garden.

Applicant is not authorized to serve alcohol in the private area on the 12th floor roof of the residential building above the establishment. The ANC will not object to the applicant applying for one-day substantial change licenses to serve alcohol in this area in the future.

5. **Sidewalk Café and Summer Garden.** The applicant plans to provide seating for 24 patrons in the sidewalk café and 32 patrons in the summer garden. There shall be no Entertainment or dancing in the sidewalk café or summer garden. The sidewalk café shall be enclosed with appropriate barriers to delineate the space designated for the outdoor seating from adjacent public areas, and may include such things as shrubbery or fencing with vines; or bushes, vines or trees in planters.

No containers, cups, bottles/cans, etc. shall be permitted outside of or to leave the area regardless of content, excepting food and beverages packaged "to go."

6. **Parking Arrangements.** It is a concern of the ANC that the Applicant's operation of the Establishment does not create or exacerbate parking problems within the ANC. The Applicant shall notify patrons (through a website or other means) that there is limited parking in the vicinity and shall provide information about public transportation.
7. **Noise and Privacy.** Applicant shall strictly comply with D.C. Official Code § 25-725 and to that end shall use various means including making architectural improvements to the property and take all necessary actions and mitigation efforts to ensure that music, noise and vibration from the Establishment are not audible in any residential premises. Options for noise mitigation can include: shrubbery, cinderblock or wooden walls (perhaps with vines), trees in planters, fountains with running water, or other muting or muffling objects.

Applicant shall inform its patrons by signage or other means that upon exiting the Establishment and walking through the neighborhood the provisions of the "Noise at Night" law prohibit persons "from making unreasonably loud noise between the hours of 10 pm and 7 am that are likely to annoy or disturb one or more persons in their residences."

Applicant shall receive all deliveries of food, beverages, and supplies during hours between 7:00 a.m. and 7:00 p.m. Mondays to Saturdays. No deliveries excepting fresh bread products, fresh produce, and seafood shall be accepted on Sundays.

8. **Public Space and Trash.** The Applicant shall participate in the building's trash removal and storage program. Trash and dumpster areas maintained by the Applicant shall be kept clean. The Applicant shall enclose its dumpsters and keep dumpster lids tightly closed and incapable of being entered by rodents, in order to limit odors and help control pest and rodent population. Applicant shall ensure that the area around the dumpster is kept clean at all times and the dumpster is placed such that it does not encroach on the abutting property owners and so that no garbage is placed on the abutting property. Applicant will provide for the proper (recyclable) removal of grease and oils and will not deposit these substances for removal in dumpsters or trash cans. Applicant will contract for regular rodent and pest (insect) abatement. Applicant shall have the Establishment and the area around the Premises properly cleaned at the end of each night to ensure that there are not garbage and odors present the following morning.
9. **Security Cooperation in Stemming Illegal Drugs and Public Drinking.** Applicant shall take all necessary steps to minimize problems of illegal drugs and public drinking, including, at all times a trained employee on site, without limitation, designating a sufficient number of employees to assure adequate security and to control unruly patrons, whether inside or in the immediate outside area; monitoring for and prohibiting sales or use of illegal drugs within or about the Premises, maintaining contact and cooperating with MPD and other enforcement officials when known or suspected drug activities occur. Applicant shall to the full extent permissible by law discourage loitering in the vicinity of the Premises.

Applicant shall have recording cameras which cover the outside areas and the areas where alcoholic beverages are served. If responsible for the video surveillance equipment, the establishment shall maintain security cameras and:: (a) Ensure the cameras are operational; (b) Maintain footage for a minimum of 30 days; and (c) Make the security footage available within 48 hours upon the request of ABRA or the Metropolitan Police Department.
10. **License Ownership and Compliance with ABRA Regulations.** Applicant promises to the ANC that it shall abide by all Alcoholic Beverage Regulations Administration (ABRA) regulations regarding the ownership of the license and all other provisions applicable to liquor licensees, and agrees that the ANC shall have standing to ask the ABC Board to enforce any violations of the agreement.
11. **Participation in the Community.** Applicant is encouraged to maintain open communication with the ANC and the community for which the ANC acts.

12. **Notice and Opportunity to Cure.** In the event that any of the parties is in breach of this Agreement, it shall be entitled to reasonable notice and opportunity to cure, as a condition precedent to seeking enforcement of the Agreement. Unless the breach is of an emergency nature or is a repetition of a prior breach, reasonable notice and opportunity shall provide for a cure within 30 days of the date of such notice. If Applicant or the licensee fails to cure within the 30-day period (or, with respect to a breach which reasonably requires more than 30-days to cure, fails to commence cure of such breach and diligently pursues such cure) failure shall constitute a cause for filing a complaint with the ABC Board pursuant to D.C. Official Code § 25-447.

AMENDMENT #1 TO COOPERATIVE AGREEMENT

THIS AMENDMENT #1 TO COOPERATIVE AGREEMENT ("Agreement") is made on this 18th day of November 2019 by and between Mission Group DOS, LLC t/a Mission Navy Yard, ABRA #108928, 1221 Van Street, SE ("Licensee"), and Advisory Neighborhood Commission 6D ("Protestant"), (collectively, the "Parties"). This amendment updates the Agreement dated March 19, 2018 and finalized by ABC Board Order 2018-131 dated March 28, 2019.

WITNESSETH

WHEREAS, Licensee has a License ABRA #108928 Class CT for a business establishment serving spirits, wine, and beer in indoor space with Entertainment and dancing endorsements inside, and a sidewalk café and second floor summer garden ("Establishment"), located at 1221 Van Street, SE #15, Washington, DC 20003 ("Premises"); and

WHEREAS, original Cooperative Agreement dated January 25, 2019 for the Establishment, paragraph #3. "Hours of Operation and Sales" indicates "Recorded music in the sidewalk café and second floor summer garden shall end no later than 10:30 p.m. on Sunday through Thursday, and 12:00 a.m. on Friday and Saturday" and

WHEREAS, the Parties request that the Alcoholic Beverage Control Board approve this Amendment to Cooperative Agreement conditioned upon the Licensee's compliance with the terms of this written Amendment and the previously executed Cooperative Agreement and Board Order and ABRA License; and

NOW, THEREFORE, in consideration of the recitals set forth above, it is mutually understood and agreed by and between the undersigned Parties to amend the previously executed Agreement as follows:

1. ***Recitals Incorporated.*** The recitals set forth above are incorporated herein by reference.
2. **Paragraph #3, "Hours of Operation and Sales"**, the sixth sentence shall be amended to read: **"Recorded music shall end in the sidewalk café and summer garden no later than 9:30 p.m. on Sunday through Thursday, and 11:00 p.m. Friday and Saturday.**
3. **Paragraph #3 "Hours of Operation and Sales"**, is also amended to add the following:
The "garage doors" between the main indoor space and the second floor summer garden shall be closed no later than:
Sunday to Thursday: 12:00 a.m., and

Friday and Saturday: 1:00 a.m.

4. **Agreement Otherwise Unamended:** Except as otherwise provided herein, the terms and conditions of the previously executed Cooperative Agreement, Board Order, and License are expressly reaffirmed and remain in full force and effect.
5. The ANC6D supports the current renewal of the license in conjunction with the licensee's signature herein and the approval of the ABC Board of this Amendment.
