21	MS. FLETCHER: Okay. Thank you.
22	And, Ms. Brown, will you please state
23	your name and spell it for the record, please?
24	MS. BROWN: Sure. Tiffany L. Brown,
25	T-I-F-F-A-N-Y, middle initial L, last name Brown,

B-R-O-W-N, ANC Commissioner for 7B-02, also ANC 1 2 7B vice chair. 3 MS. FLETCHER: Okay. Thank you very 4 much. ANC 7B does have standing as a protestant. 5 We need to set a date for a mediation and a status hearing. The date for the status hearing 6 is February 11. February 11, 2021 at 10:30 a.m. 7 8 for the status hearing. 9 Let's see here. I'll give you the 10 next available day for mediation. One second. 11 The next available date for mediation 12 is Tuesday, January 5. If that's too soon, we 13 can move to the -- actually, any day that week. 14 That's just the next day available, any time 15 between 9:00 and 2:00. 16 Ms. Brown, did you need something 17 further out? 18 MS. BROWN: No, not necessarily. 19 There is already a settlement agreement that's not being followed, so I guess we would be 20 21 looking to have the settlement agreement-22 agreement followed. So Wednesdays simply are 23 better days for me. 24 Okay. Well, let's --MS. FLETCHER: 25 MS. BROWN: So I'm already coming on
