Pursuant to D.C. Official Code § 25-433(d)(1), any party adversely affected may file a Motion for Reconsideration of this decision within ten (10) days of service of this Order with the Alcoholic Beverage Regulation Administration, 2000 14th Street, N.W., Suite 400S, Washington, DC 20009.

Also, pursuant to section 11 of the District of Columbia Administrative Procedure Act, Pub. L. 90-614, 82 Stat. 1209, D.C. Official Code §2-510 (2001), and Rule 15 of the District of Columbia Court of Appeals, any party adversely affected has the right to appeal this Order by filing a petition for review, within thirty (30) days of the date of service of this Order, with the District of Columbia Court of Appeals, 430 E Street, N.W., Washington, D.C. 20001; (202/879-1010). However, the timely filing of a Motion for Reconsideration pursuant to 23 DCMR §1719.1 (2008) stays the time for filing a petition for review in the District of Columbia Court of Appeals until the Board rules on the motion. See D.C. App. Rule 15(b) (2004).

AMENDMENT TO SETTLEMENT AGREEMENT

This Amendment to Settlement Agreement ("Amendment") is made this 15th day of October 2018 by and between El Sol, LLC ("Applican") and Advisory Neighborhood Commission 2F ("ANC 2F"), and the Logan Circle Community Association ("LCCA") (jointly "the Community").

RECITALS

- (a) Applicant has applied for a Retailer Class "C" License (the "License") for a business establishment ("Establishment") located at 1227 11th Street, NW, Washington, DC (the "Premises"); and,
- (b) Applicant desires to cooperate with the ANC in order to mitigate concerns related to the potential impact of operation of the Establishment on the surrounding community; and,
- (c) Applicant entered into this Amendment agreement with the Community and to request further that the ABC Board approve Applicant's request be conditioned upon Applicant's compliance with the terms of those certain written Settlement Agreement dated October 7th, 2015, as approved by the ABC Board;

NOW, THEREFORE, in consideration of the recitals set forth above and the mutual covenants and conditions set forth below, the Parties agree as follows:

- 1. Recitals Incorporated. The recitals set forth above are incorporated herein by reference.
 - 2. <u>Section 4 Sidewalk Café.</u> Section 4 of that certain Settlement Agreement dated October 7th, 2015 is amended hereby by replacing Section 4 to read:
 - "4. Sidewalk Café. The Applicant may have outside scating in accordance with a sidewalk café endorsement to its ABC license and a duly-issued public space permit and may serve alcoholic beverages to scated patrons in such area, provided, the total capacity for such sidewalk cafe shall not exceed 12 seats. Any increase in such seating shall require approval of the District of Columbia Public Space Committee and approval by the ABC Board. Applicant shall not serve alcoholic beverages on its sidewalk café later than
 - a. Sunday Thursday: 8am to 11:00pm
 - b. Friday Saturday: 8am to 12:00am

Applicant will inspect the sidewalk cafe regularly for compliance.
