3 CHAIRPERSON ANDERSON: Good morning.

4 As chairperson of the Alcoholic Beverage and
5 Cannabis Board for the District of Columbia and
6 in accordance with D.C. Code, Section 2571C of
7 the Open Meetings Act, I am regular -- I am
8 welcoming you to the regularly scheduled meeting
9 of the Alcoholic Beverage and Cannabis Board.

10 This meeting's being conducted
11 pursuant to guidance made available by the
12 District of Columbia's Office of Open Government
13 regarding electronic meetings held by public
14 bodies. Electronic meetings by the ABC Board are
15 authorized pursuant to Section 2577A of the DC
16 Code.

17 Pursuant to the OMA requirements,
18 notice of today's meeting was provided 48 hours
19 in advance of the meeting on ABCA's website and
20 on the District Central Meeting Calendar. The
21 notice includes the time, date, agenda, and call-

3 My name is Donovan Anderson and I'm
4 chairperson of the board. I would like to
5 introduce the other members of the ABC Board who
6 are also participating electronically. Please
7 respond when I announce your name. Mr. James
8 Short?

9 (No audible response.)

10 CHAIRPERSON ANDERSON: I can't hear
11 you, Mr. Short.

12 MEMBER SHORT: Mr. James Short,
13 present.

14 CHAIRPERSON ANDERSON: Mr. Silas
15 Grant?

16 MEMBER GRANT: Good morning, Mr. Silas
17 Grant, present.

18 CHAIRPERSON ANDERSON: The board has
19 three members in attendance for the conduct of
20 business today and that constitutes a quorum.
21 Before we get underway with today's hearing
22 calendar I need to make a few instructions that
23 are clear so that the conduct of this hearing is
24 understood by everyone.

25 There is just one case on our calendar

1 today. Should you have any questions or require
2 technical assistance during the hearing please
3 submit them using the question and answer
4 feature. But before I go to our calendar today,
5 let me -- all right.

6 So before I go to our calendar today,
7 so let me do our agenda items. The first agenda
8 item to address today is our legal agenda. The
9 first matter on our legal agenda is review of
10 petitioner's request dated December 4, 2020 --
11 December 14, 2023, to conduct the North Shaw
12 Proposed Rulemaking Hearing to an alternative
13 date in February of 2024. I make a motion that
14 we grant this request. The new hearing date is
15 now February 9, 2024 at 10:00 a.m. Is there a
16 second?

17 MEMBER SHORT: Mr. Short, I second.

18 CHAIRPERSON ANDERSON: Mr. Short has
19 seconded the motion. We'll now have a roll call
20 vote. Mr. Short?

21 MEMBER SHORT: Mr. Short, I agree.

22 CHAIRPERSON ANDERSON: Mr. Grant?

23 MEMBER GRANT: Mr. Grant, I agree.

24 CHAIRPERSON ANDERSON: And Mr.
25 Anderson, I agree. The matter passes 3-0. We

1 now move to our licensing agenda.

2 The first matter on our licensing
3 agenda is a review application for a Stipulated
4 License with letter of ANC Support for a Change
5 of Hours of Operation. This is for Moi Moi
6 Restaurant, License Number 120466. I make a
7 motion that we approve this request. Is there a
8 second?

9 MEMBER GRANT: Mr. Grant, I second the
10 motion.

11 CHAIRPERSON ANDERSON: Mr. Grant has
12 seconded the motion. We'll have a roll call
13 vote. Mr. Short?

14 MEMBER SHORT: Mr. Short, I agree.

15 CHAIRPERSON ANDERSON: Mr. Grant?

16 MEMBER GRANT: Mr. Grant, I agree.

17 CHAIRPERSON ANDERSON: And Mr.
18 Anderson, I agree. The matter passes 3-0.

19 Number two, Review Application for a
20 Stipulated License with letter of ANC Support for
21 a New ABC License. This is for Sampannee Thai
22 Food, License Number 126865. I make a motion
23 that we approve this request. Is there a second?

24 MEMBER SHORT: Mr. Short, I second.

25 CHAIRPERSON ANDERSON: Mr. Short has

1 seconded the motion. We'll have a roll call
2 vote. Mr. Short?

3 MEMBER SHORT: Mr. Short, I agree.

4 CHAIRPERSON ANDERSON: Mr. Grant?

5 MEMBER GRANT: Mr. Grant, I agree.

8 Number three, Review Application for
9 a Summer Garden Endorsement with 118 seats, Total
10 Capacity of 20 -- 254. Request to extend the
11 approved Entertainment Endorsement to a Summer
12 Garden space. This is for The Westin Washington,
13 DC Downtown, License Number 085654. I make a
14 motion that we placard this request. Is there a
15 second?

16 MEMBER GRANT: Mr. Grant, I second.

17 CHAIRPERSON ANDERSON: Mr. Grant has
18 seconded the motion. We'll now have a roll call
19 vote. Mr. Short?

20 MEMBER SHORT: Mr. Short, I agree.

21 CHAIRPERSON ANDERSON: Mr. Grant?
