6 Would the parties, please, approach
7 and identify themselves for the record, please?

21 witnesses we have not seen before. So seven days
22 prior to February 13th if you have any witnesses

1 you are going to call or any documents to support
2 your position, they need to be exchanged with
3 each side and also with the Agency.

4 Okay? All right. Thank you. See you
5 on February 13th at 1:30.

6 MR. ATAKPAH: Thank you, Your Honor.

7 CHAIRPERSON ANDERSON: You're welcome.
