4	there is a fine of \$1,500 payable in 60 days and

6	license will be suspended until the fine has been
7	paid.
8	Is this your understanding, ma'am, of
9	the Offer in Compromise?
10	MS. FLETCHER: Yes, it is.
11	CHAIRPERSON ANDERSON: Are you aware
12	that by accepting an Offer in Compromise, that
13	you are giving up your right to a hearing?
14	MS. FLETCHER: Yes.
15	CHAIRPERSON ANDERSON: Are you also
16	aware that by accepting an Offer in Compromise,
17	that you are giving up your right to appeal this
18	matter?
19	MS. FLETCHER: Yes.
20	CHAIRPERSON ANDERSON: Okay. With
21	that said, I then make a motion that the Offer in
22	Compromise of a fine of \$1,500 payable in 60 days

1	be accepted. If the fine is not payable in 60			
2	days, the license will be suspended until the			
3	fine has been paid.
