ORDER CANCELLING LICENSE


The Alcoholic Beverage Regulation Administration (ABRA) has reviewed its records and determined that Red & Black, LLC, t/a 12 Twelve DC/Kyss Kyss (Respondent), has failed to pay the second year license fees for its license by September 30, 2020, the deadline for all Retailer's CT licenses, despite being notified by ABRA of the payment date.

Also, pursuant to section 11 of the District of Columbia Administrative Procedure Act, Pub. L. 90-614, 82 Stat. 1209, D.C. Official Code §2-510 (2001), and Rule 15 of the District of Columbia Court of Appeals, any party adversely affected has the right to appeal this Order by filing a petition for review, within thilty (30) days of the date of service of this Order, with the District of Columbia Coult of Appeals, 430 E StTeet, N.W., Washington, D.C. 20001; (202/879-1010). However, the timely filing of a Motion for Reconsideration pursuant to 23 DCMR §1719.1 (2008) stays the time for filing a petition for review in the District of Columbia Court of Appeals on the motion.
