8	60 day period, the license shall be suspended
9	indefinitely until the fine is paid.
10	CHAIRPERSON ANDERSON: All right. Ms.
11	Fletcher, it's my understanding that there is an
12	Offer in Compromise and the Offer in Compromise
13	is that there is a fine of \$1,500 payable within
14	60 days. If the fine is not payable in 60 days,
