10 #ABRA-070728. This is a Retailer Class CT  
11 License Renewal.

12 The protest issues are adverse impact  
13 on peace, order and quiet, residential parking  
14 and vehicular and pedestrian safety and real  
15 property values.

8 26, 2020 at 9:30. That's for the status hearing,  
9 February 26th at 9:30.

10 The protest hearing is set for April  
11 1st, April 1st, 2020 at 4:30 for the protest  
12 hearing, April 1 at 4:30.

13 We need to set a date for mediation.  
14 I'll give you the next available day. The next  
15 available day for mediation is actually on a  
16 Wednesday. And I'm mentioning that because, Ms.  
17 Yohannes, do you by any chance know if you have  
18 any hearings before the Board on that day?

19 MS. YOHANNES: I probably do.

20 MS. FLETCHER: Do you want to take a  
21 chance?

22 MS. YOHANNES: I'd like to -- yeah.

23 MS. FLETCHER: Let me just -- okay,  
24 let me keep moving. The next available day is  
25 Tuesday, January 28, anytime between 9:00 and

1 2:00. That's on Tuesday, January 28.

2 MS. YOHANNES: Can we do 1:30 on that  
3 date?

4 MS. FLETCHER: Does that work for you,  
5 Ms. Norman:

6 MS. NORMAN: Yes.

7 MS. FLETCHER: Ms. Yohannes, how do  
8 you pronounce E-T-E-T-E?

9 MS. NORMAN: Etatay.

10 MS. FLETCHER: Thank you. Mediation  
11 is set for Tuesday, January 28, at 1:30.

12 The roll call hearing is concluded.

14 MS. YOHANNES: Thank you.
