**FREQUENTLY ASKED QUESTIONS:**

**Who is eligible to participate?**

All on-premises establishments that do not have a settlement agreement or Board Order with any closing hours restrictions. Temporary license applications are also eligible under the law.

**What is the five-night period covered by the law?**

The five-night period starts at midnight on Friday night, July 13 into Saturday morning, July 14. It ends at 4 a.m. on Wednesday, July 18.

**What is the fee and when is the deadline for registration?**

The fee for registration is \$100, which covers the entire eligible period. The deadline to register is Tuesday, July 3, 2018.

**Do I need to submit a public safety plan?**

Yes, you need to submit a public safety plan with your application. You may resubmit a current public safety plan already on file with ABRA. If you do not have a public safety plan on file, you can find this document on the reverse page of this registration form.

**Does the law extend the hours of my entertainment endorsement?**

No, you would need to file a one-day substantial change application with ABRA to extend the hours of entertainment listed on your entertainment endorsement.

**Where do I submit the registration form?**

Registration forms may be submitted to ABRA by email (abc@dc.gov), mail or in person at: 2000 14th Street, NW, Suite 400S, Washington, DC, 20009 (Office Hours: 8:30 a.m.-3:30 p.m., Monday-Friday).

**What happens after I am approved?**

Once a licensee is registered in the program, ABRA will provide the licensee with a separate 2018 All-Star Game license, which must be posted in a visible location at the establishment for the five day period. ABRA will notify the Metropolitan Police Department of all registered establishments.

NOTICE: The District of Columbia will provide the appropriate services and auxiliary aids, including sign language interpreters, whenever necessary to ensure effective communication with members of the public who are deaf, hearing impaired or who have other disabilities affecting communications.
