The Agreement has been reduced to writing and has been properly executed and filed with the Board. The Licensee and Chairperson Brian Turmail, on behalf of ANC 3B, are signatories to the Agreement.

Accordingly, it is this 3rd day of November 2021, **ORDERED** that:

1. The above-referenced Settlement Agreement submitted by the parties to govern the operations of the Licensee's establishment is **APPROVED** and **INCORPORATED** as part of this Order; and

Pursuant to D.C. Official Code § 25-433(d)(1), any party adversely affected may file a Motion for Reconsideration of this decision within ten (10) days of service of this Order with the Alcoholic Beverage Regulation Administration, 2000 14<sup>th</sup> Street, N.W., Suite 400S, Washington, DC 20009.

Also, pursuant to section II of the District of Columbia Administrative Procedure Act, Pub. L. 90-614, 82 Stat. 1209, D.C. Official Code §2-510 (2001), and Rule 15 of the District of Columbia Court of Appeals, any party adversely affected has the right to appeal this Order by filing a petition for review, within thirty (30) days of the date of service of this Order, with the District of Columbia Court of Appeals, 430 E Street, N.W., Washington, D.C. 20001; (202/879- 1010). However, the timely filing of a Motion for Reconsideration pursuant to 23 DCMR §1719.1 (2008) stays the time for filing a petition for review in the District of Columbia Court of Appeals until the Board rules on the motion. See D.C. App. Rule 15(b) (2004).

**SETTLEMENT AGREEMENT**  
**LAXMI DC LLC t/a Laliguras ABRA Lic. #115606**

WHEREAS, LAXMI DC LLC t/a Laliguras ("Laliguras") has applied to the Alcoholic Beverage Regulation Administration to change its hours and add an entertainment endorsement to its Class CR liquor license;

WHEREAS, ANC3B has received no complaints or concerns about the operations of Laliguras, located at 2332 Wisconsin Avenue;

WHEREAS, ANC3B has requested community comment on the proposed changes to hours of alcohol service, closing times, and entertainment, and has received encouragement to allow Laliguras to extend its hours commensurate with similar licensed establishments in Glover Park and provide entertainment in the form of karaoke singing;

THEREFORE, Laliguras has agreed to the following limits on its hours of operation and entertainment, and ANC3B has agreed to request permission from the Alcoholic Beverage Control Board for Laliguras to begin operating with a stipulated entertainment endorsement subject to these terms immediately after the Board approves this settlement agreement.

1. Laliguras' hours of operation will be 11 a.m. to 2 a.m. Sunday through Thursday, and 11 a.m. to 3 a.m. Friday and Saturday.

2. Laliguras' hours of alcohol service will be 11 a.m. to 2 a.m. Sunday through Thursday, and 11 a.m. to 3 a.m. Friday and Saturday.

3. Laliguras' hours of entertainment will be 11 a.m. to 1 p.m. Sunday through Thursday, and 11 a.m. to 2 a.m. Friday and Saturday.

4. Laliguras agrees to regulate its entertainment so that no sound can be heard outside its premises, in accordance with the noise regulations enforceable by ABRA.

5. This agreement shall be binding upon any person or entity to whom the license is sold, transferred or assigned.

The above five paragraphs constitute the full extent of the Settlement Agreement between ANC3B and Laliguras.
