3 CHAIRPERSON ANDERSON: The next case
4 on our Protest Hearing (Status) is Case No. 18-
5 PRO-00038, 4 Seasons Convenience Store, License
6 No. 109434.

7 Is there anyone here for 4 Seasons
8 Convenience Store?

9 MR. EDWARDS: ANC-5A.

10 CHAIRPERSON ANDERSON: Move forward,
11 sir. All right. You know what, what I'm going
12 to do, I'm going to give them 3 more minutes and
13 I'm going to recall the other cases that I did
14 not call before I move on to the -- ANC-5A is
15 here. I'm going to move on to -- so let me --
16 I'm going to recall the other cases and if they
17 are not here when I recall the case, because this
18 matter was scheduled for 9:30, I'll make a motion
19 to dismiss the case, so they would have to -- all
20 right. All right.

21 (Whereupon, the above-entitled matter
22 went off the record at 9:56 a.m. and resumed at

2 CHAIRPERSON ANDERSON: Let me now call
3 Case No. 18-PRO-00038, 4 Seasons Convenience
4 Store, License No. 109434.

5 Will the parties, please, approach and
6 identify themselves for the record, please?

7 MR. EDWARDS: Good morning. My name
8 is Ronnie Edwards, Chairman of ANC-5A.

9 CHAIRPERSON ANDERSON: Good morning,
10 Mr. Edwards.

11 MS. LEWIS: My name is Grace Lewis,
12 Commissioner of ANC-5A02.

13 CHAIRPERSON ANDERSON: All right.
14 Good morning, Ms. Lewis.

15 I do not see the licensee here. This
16 matter was scheduled for a Protest Hearing
17 (Status) at 9:30. The case was called. The
18 licensee is not here. I recalled the case. It
19 is now 10:04 and the licensee is not here.

20 Because the licensee is not here, I
21 then make a motion that we dismiss this
22 application. Is there a second?

1 MEMBER SHORT: Second.

2 CHAIRPERSON ANDERSON: Mr. Short has
3 seconded the motion.

4 All those in favor say aye.

5 ALL: Aye.

6 CHAIRPERSON ANDERSON: All those
7 opposed? The matter passes 6-0-0.

8 What this means is that the license --
9 the application that was applied for a new
10 license will be dismissed. We will send them a
11 notice to let them know that we had this hearing,
12 they failed to apply. They have 10 days to give
13 the Board reasonable notice why they did not show
14 up this morning.

15 If they do not -- if that deadline is
16 not met, then this matter goes away. All right.
17 So thank you for being here this morning. Thank
18 you very much.

19 MR. EDWARDS: Thank you.

20 CHAIRPERSON ANDERSON: All right.

21 MS. LEWIS: We have to sign-in.

22 MR. EDWARDS: Oh, yeah.
