The official records of the Alcoholic Beverage Control Board (Board) reflect that Stephen Lawrence, t/a 600 T (Licensee), and ANC 6E entered into a Settlement Agreement (Agreement), dated July 5, 2022, in accordance with D.C. Official Code § 25-446 (2001).

The Agreement has been reduced to writing and has been properly executed and filed with the Board. The Licensee and Chairperson Michael Eichler, on behalf of ANC 6E, are signatories to the Agreement.

Accordingly, it is this 3rd day of August 2022, **ORDERED** that:

1. The above-referenced Settlement Agreement submitted by the Parties to govern the operations of the Licensee's establishment is **APPROVED** and **INCORPORATED** as part of this Order; and
2. Copies of this Order shall be sent to the Licensee and ANC 6E.

Pursuant to D.C. Official Code § 25-433(d)(1), any party adversely affected may file a Motion for Reconsideration of this decision within ten (10) days of service of this Order with the Alcoholic Beverage Regulation Administration, 2000 14th Street, N.W., Suite 400S, Washington, DC 20009.

Also, pursuant to section II of the District of Columbia Administrative Procedure Act, Pub. L. 90-614, 82 Stat. 1209, D.C. Official Code §2-510 (2001), and Rule 15 of the District of Columbia Court of Appeals, any party adversely affected has the right to appeal this Order by filing a petition for review, within thirty (30) days of the date of service of this Order, with the District of Columbia Court of Appeals, 430 E Street, N.W., Washington, D.C. 20001; (202/879- 1010). However, the timely filing of a Motion for Reconsideration pursuant to 23 DCMR §1719.1 (2008) stays the time for filing a petition for review in the District of Columbia Court of Appeals until the Board rules on the motion. See D.C. App. Rule 15(b) (2004).

Recitations

WHEREAS, Stephen Lawrence ("Applicant"), is the holder of Retailers Class "C" Tavern License for 600 T (License Number ABRA-100515); and,

WHEREAS, 600 T is located at 600 T Street NW within the jurisdictional boundary of Advisory Neighborhood Commission 6E ("ANC 6E"); and,

WHEREAS, the Applicant has filed an application for approval of a substantial change of operation, including an application for an entertainment endorsement ("Application") with the Alcoholic Beverage Control Board ("ABC Board"); and,

WHEREAS, the Applicant seeks approval of an entertainment endorsement at 600 T located at 600 T Street NW ("Establishment"); and,

WHEREAS, the Applicant and ANC 6E (collectively, the "Parties") desire to resolve potential issues in the operation of the Establishment and enter into this Settlement Agreement ("Agreement") in exchange for ANC 6E's not filing a protest against the Application;

NOW, THEREFORE, in consideration of the recitals set forth above and the mutual covenants and conditions set forth below, the Parties agree as follows:


1. **Recitals Incorporated.** The recitals set forth above are incorporated herein by reference.
2. **Noise.** The Applicant will comply with D.C. Official Code §25-725 regarding noise from the Establishment.
3. **Entertainment Endorsement.** The Applicant agrees to the following terms and conditions regarding the ANC's support of an entertainment endorsement:
 - a. The Applicant shall ensure that Entertainment be contained to the inside portion of the Establishment. There shall be no Entertainment allowed outdoors, including in the Summer Garden.
 - b. The Applicant shall ensure that all doors and windows be shut during times when Entertainment is occurring inside the Establishment, with the brief exceptions to allow for customer and staff ingress and egress;
4. **No Protest.** Upon execution of this Settlement Agreement and its acceptance by the ABC Board, ANC 6E agrees to support Applicant's pending Application.

In witness thereof, the Parties, acting through their authorized representatives, have agreed to and signed this Settlement Agreement.
