The applicant is represented by Matt Minora of Malios and O'Brien. He gave a plan of operation, including hours. He answered the Commissioner's questions. Commissioner Shankle pointed out that most hotels are now offering beer and wine in their gift shops and he had no problems with the application or with granting a stipulated license. The community had no objections to this application either. The commission agreed to support the license and a stipulated license.

The Commissioners voted unanimously, 3:0:0, to support a stipulated license for a Class B 25% license.
