## ORDER VACATING CEASE AND DESIST

On May 7, 2025, the Alcoholic Beverage and Cannabis Board (Board) issued Board Order No. 2025-484 ordering Across the Pond, LLC, t/a Across the Pond Restaurant & Pub (Respondent), holder of a Retailer's Class CR License No. ABRA-106099, to stop selling, serving, or permitting the consumption of alcoholic beverages at the Respondent's establishment until the renewal application and payment of the license fees, late fees, and any unpaid fines are received by Alcoholic Beverages and Cannabis Administration (ABCA).

On May 20, 2025, the Respondent submitted the renewal application and paid the license fees and the associated late fees.

It is hereby **ORDERED** that the **ORDER TO CEASE AND DESIST** issued against the Respondent by the Board on May 7, 2025, pursuant to D.C. Official Code § 25-829 (2001), be and hereby is **VACATED**.

Pursuant to D.C. Official Code § 25-433(d)(1) (applicable to alcohol matters) or 22-C DCMR § 9720 (applicable to medical cannabis matters), any party adversely affected may file a Motion for Reconsideration of this decision within ten (10) days of service of this Order with the Alcoholic Beverage and Cannabis Administration, 899 North Capitol Street NE, Suite 4200 B (Alcohol Division), Suite 4200 A (Medical Cannabis Division), Washington, DC 20002.

Also, pursuant to section II of the District of Columbia Administrative Procedure Act, Pub. L. 90-614, 82 Stat. 1209, D.C. Official Code § 2-510 (2001), and Rule 15 of the District of Columbia Court of Appeals, any party adversely affected has the right to appeal this Order by filing a petition for review, within thirty days of the date of service of this Order, with the District of Columbia Court of Appeals, 430 E Street, N.W., Washington, D.C. 20001 (202/879- 1010). However, the timely filing of a Motion for Reconsideration stays the time for filing a petition for review in the District of Columbia Court of Appeals until the Board rules on the motion. *See* D.C. App. Rule 15(b) (2004).
