ORDER DENYING RECONSIDERATION

On September 25, 2019, in Board Order No. 2019-668, the Alcoholic Beverage Control Board (Board) dismissed the above listed Protestant for failing to appear at the required Protest Status Hearing on September 25, 2019, without good cause. 23 DCMR § 1604.3 (West Supp. 2019). The Protestant now requests reconsideration and reinstatement.

On August 29, 2019, ABRA communicated to the protestant that their protest was dismissed and that the Protest Status Hearing scheduled for September 25, 2019, was cancelled. On September 10, 2019, the Protestant was informed that the Protest Status Hearing was reinstated and that the Protestant's attendance was required. The Protestant did not file a motion for continuance before the hearing or appear at the required hearing. Under these circumstances, there are no grounds for excusing the absence and dismissal of the Protestant is justified.

ORDER
