CHAIRPERSON ANDERSON: Let's do our legal agenda. The first matter in our legal agenda is a review of the Kiss Tavern's motion for reconsideration of Board Order No. 2019-037, Kiss Tavern, License No. 104710.

I make a motion that we deny the request.

MR. SILVERSTEIN: Second.

9 CHAIRPERSON ANDERSON: Those opposed?

10 The matter has passed four-zero-zero.

11 We now move to our supplemental legal
12 agenda. The first matter on our supplemental
13 legal agenda is review of ANC 3D's letter dated
14 February 6, 2019, regarding Millie's Restaurant,
15 License No. 100214. This is an FYI to the Board.

17 settlement agreement dated February 6, 2019,
18 between Reveler's and ANC 1C and the Kalorama
19 Citizens Association.

9 settlement agreement dated February 6, 2019,
10 between Alta Strada and ANC 6E.

21 The next matter is to review a Kiss
22 Tavern supplementary motion for reconsideration

1 of Board Order No. 2019-037. This is Kiss Tavern
2 License No. 104710.

3 I make a motion that we deny the
4 request.

5 Is there a second?

6 MR. SILVERSTEIN: Second.

7 CHAIRPERSON ANDERSON: Mr. Silverstein
8 has seconded the motion.

9 All those in favor say aye.

10 (Chorus of ayes.)

11 CHAIRPERSON ANDERSON: Those opposed?

12 The matter passes four-zero-zero.

13 The next matter to review is the
14 government's opposition to Kiss Tavern's motion
15 for reconsideration and supplementary motion for
16 reconsideration. This matter is now moot.

17 The next matter to review of the first
18 amendment to settlement agreement dated February
19 5th, 2019, between ANC 2E, the Citizens
20 Association of Georgetown, and the Escape Room.

21 I make a motion that we approve this
22 request.

3 CHAIRPERSON ANDERSON: Mr. Short has

6 (Chorus of ayes.)

7 CHAIRPERSON ANDERSON: Those opposed?

11 review application for safekeeping of license for
12 Ruta Del Vino, License No. 101091.

17 application for change of hours for Jo Jo's
18 Restaurant and Bar, License No. 060737.
