7 CHAIRPERSON ANDERSON: Mr. Grandis?

8 MEMBER GRANDIS: Ed Grandis, I agree.

9 CHAIRPERSON ANDERSON: Mr. Anderson,

10 I agree. The matter therefore passes 7-0-0.

11 The next matter on our agenda is a  
12 review letter from Heidi Arnold of the American  
13 Heart Association requesting to change the date  
14 of the online event, for the second time, for an  
15 approved non-profit corporation auction permit to  
16 auction items containing alcoholic beverages,  
17 such as wine donations.

18 The Heart's Delight online fundraiser  
19 auction to be held on Friday, May 29th, 2020 has  
20 been moved to June 18th, 2020. This is license  
21 number 19-AUCTION-00001. The Board had  
22 originally approved to move the event to  
23 May 28th, 2020. So I, therefore, make a motion  
24 that we agree to this change date. Is there a
