MEMBER SILVERSTEIN: Mr. Chairman, this is a difficult issue for me personally. The protestant in this case asked that the hearing be moved because it conflicted with the Jewish high holiday of Yom Kippur. The protestant emailed to request a change and was advised that there was consent of the applicant required.

The applicant in that case denied, but the protestant did not follow-up with the Board.

I do not believe that -- I do believe that the failure to follow-up is the fatal flaw here. It is a difficult situation, but had the person simply called and said this was the state of play, we would have had the opportunity to rectify this.

He did not and we were unable to do so. It is extremely unfortunate, but that was the failure there. Thank you, Mr. Chairman.

CHAIRPERSON ANDERSON: Thank you, Mr.

Silverstein. I just wanted this case for the record, the protestant had requested -- had stated that because it was a religious holiday at the Roll Call Hearing, that they might not be able to attend.

The protestant from that group was specifically given instruction to contact the legal to get further instructions. The protestant did contact legal. Legal told -- informed him that he needed to get the consent of the additional parties. He did reach out, the protestant did reach out to the other parties. The other parties denied his request.

We had the hearing. The protestant was not here. There was no -- the protestant did not inform the Board that he could not -- that neither him or the missing members of his group could not appear based on a religious observation.

The protestant basically stated that he did not follow-up. After the other parties denied his request, he dropped the ball. And so

1	therefore, because the protestant was given
2	specific instructions and what to do and that was
3	not done, from a legal perspective, the Board has
4	no choice but to deny the request.
