14 between Players Club and ANC-2F. Players Club,

18 MEMBER SILVERSTEIN: Second.

19 CHAIRPERSON ANDERSON: Mr. Silverstein
20 has seconded the motion.

22 ALL: Aye.

1 CHAIRPERSON ANDERSON: Those opposed?
2 The matter passes 5-0-0.

3 The next matter on our agenda is the
4 review of the Complaint to Show Cause Why the
5 Trump International Hotel Alcoholic Beverage
6 License should be revoked dated June 25, 2018.
7 Trump Old Post Office t/a Trump International
8 Hotel, License No. 100648.

9 The other matter on our agenda is No.
10 8, and I will give our decision once I review all
11 three, is a review of the Supplement to Complaint
12 to Show Cause Why the Trump International Hotel
13 Alcoholic Beverage License Should Not be Revoked.
14 This is dated July 10, 2018.

15 The next matter on our agenda, No. 9,
16 is the review of the Second Supplement to
17 Complaint to Show Cause Why the Trump
18 International Hotel Alcoholic Beverage License
19 Should Not be Revoked. This is dated August 21,
20 2018. Trump Old Post Office t/a Trump
21 International Hotel, License No. 100648.

22 On June 20, 2018, the Alcoholic

1 Beverage Regulation Administration, ABRA,
2 received a complaint from Attorney Joshua A. Levy
3 on behalf of seven individuals regarding the
4 Trump Old Post Office, LLC t/a Trump
5 International Hotel, which holds a Retailer's
6 Class C Hotel License.

7 ABRA also received three additional
8 supplements to the complaint dated July 10th,
9 August 21st and September 6, 2018.

10 In the complaint and its supplements,
11 Mr. Levy requested that the Alcoholic Beverage
12 Control Board hold a Show Cause Hearing to
13 determine whether the owner of the Trump
14 International Hotel License satisfies the
15 character and fitness requirements for a licensee
16 -- licensure pursuant to District of Columbia
17 Code Section 25-301, General qualification for
18 all applicants.

19 The complaint and supplements
20 specifically requested that the owner of the
21 Trump International Hotel License be ordered to
22 show cause before the Board as to why the license

1 should be revoked pursuant to Section 25-301,
2 which states in relevant part that "Before
3 issuing, transferring to a new owner, or renewing
4 a license, the Board shall determine that the
5 applicant is of good character and generally fit
6 for the responsibilities for licensure."

7 The complainant and supplements claim
8 that Donald J. Trump is the true and actual owner
9 of the license and cite a number of instances
10 that call into question Trump's good character.

11 While the complainant acknowledges
12 that the Board's good character investigations
13 typically occur at the time of license
14 application or renewal, it claims that the
15 egregious nature of the conduct of the license
16 owner necessitates the initiation of a show cause
17 proceeding to review his character and fitness
18 for licensure before renewal.

19 Upon receipt, the complaint and
20 supplements were sent to ABRA's Enforcement
21 Division for review. As part of the review
22 process, ABRA Investigators conducted a

1 regulatory inspection on the Trump International
2 Hotel to ensure that the licensee is compliant
3 with the law.

4 ABRA Investigators did find an alleged
5 sale to minor violation that would be placed --
6 that will be placed on the Board's Investigative
7 Agenda on September 26, 2018.

8 However, this violation did not have
9 any bearing on the efficacy of this complaint.

10 ABRA was required by law to respond to
11 this complaint within 90 days of receipt or by
12 September 18, 2018 and did so today in a letter
13 addressed to Mr. Levy.

14 The letter conveyed that the Board has
15 decided not to hold a Show Cause Hearing, at this
16 time, regarding the owner of the Trump
17 International Hotel's fitness for licensure.

18 The Board does not agree with the
19 assumption that a character and fitness review
20 may be initiated at any time.

21 The law pursuant to 25-301 states that
22 "The standards for review of good character apply

1 before issuing, transferring to a new owner, or
2 renewing a license."

3 And the Board finds that these are the
4 appropriate times to review the question of
5 fitness.

6 Consequently, the request in the
7 complaint cannot be acted upon by the Board, at
8 this time.

9 It is important to note that all hotel
10 liquor license holders in the District of
11 Columbia are required to apply for renewal of
12 their license by March 31, 2019, if they seek to
13 retain them.

14 And that's our position on that
15 matter.

16 We now go back to our regular agenda.
17 We now move to No. 10 on our agenda, review of
18 the letter from the Metropolitan Police
19 Department dated August 27, 2018 requesting the
20 Board hold a Fact-Finding Hearing concerning the
21 events that took place on August 26, 2018 at
22 Tacoma Station, License No. 078270.

1 I make a motion that we have a Fact-
2 Finding Hearing on this matter. Is there a
3 second?

4 MEMBER SHORT: Second.

5 CHAIRPERSON ANDERSON: Mr. Short has
6 seconded the motion.

7 All those in favor say aye.

8 ALL: Aye.

9 CHAIRPERSON ANDERSON: Those opposed?
10 The matter passes 5-0-0.

11 We now move to our Supplemental Legal
12 Agenda, which was a review of the Third
13 Supplement to Complaint to Show Cause Why the
14 Trump International Hotel Alcoholic Beverage
15 License Should Not be Revoked. Trump
16 International Hotel, License No. 100648.

17 And this is also an FYI, based on the
18 statement that was just read by me.

19 We now move to our Second Supplemental
20 Legal Agenda.

21 The first matter on our Second
22 Supplemental Legal Agenda is the review of a

1 settlement agreement dated August 30, 2018
2 between Chanterelle and the Citizens Association
3 of Georgetown, License No. 109998.

4 I make a motion that we approve this
5 agreement with modifications. Is there a second?

6 MEMBER SILVERSTEIN: Second.

7 CHAIRPERSON ANDERSON: Mr. Silverstein
8 has seconded the motion.

9 All those in favor say aye.

10 ALL: Aye.

11 CHAIRPERSON ANDERSON: Those opposed?
12 The matter passes 5-0-0.

13 The next matter is the review of ANC-
14 6E's request for reinstatement of its protest
15 letter regarding Communal Restaurant's
16 substantial change application. Communal
17 Restaurant, License No. 108392.

18 I make a motion that we deny this
19 request. Is there a second?

20 MEMBER SILVERSTEIN: Second.

21 CHAIRPERSON ANDERSON: Mr. Silverstein
22 has seconded the motion.

1 All those in favor say aye.

2 ALL: Aye.

3 CHAIRPERSON ANDERSON: Those opposed?

4 The matter passes 5-0-0.

5 The next matter is the review of an
6 amended settlement agreement dated September 10,
7 2018 between All Purpose Pizzeria and ANC-6D.
8 All Purpose Pizzeria, License No. 103856.

9 I make a motion that we approve this
10 request. Is there a second?

11 MEMBER ALBERTI: Second.

12 CHAIRPERSON ANDERSON: Mr. Alberti has
13 seconded the motion.

14 All those in favor say aye.

15 ALL: Aye.

16 CHAIRPERSON ANDERSON: Those opposed?

17 The matter passes 5-0-0.

18 And so I'm going to go back to our
19 regular agenda.

20 (Whereupon, the Cancellation,
21 Licensing, Legal and Investigative Agenda Hearing
