Good morning, everyone. I would like to welcome you to the regularly scheduled meeting of the District of Columbia Alcoholic Beverage Control Board. Please know that today's hearings will be conducted in accordance with D.C. Official Code Section 2-574 of the Open Meetings Act.

Today is July 17, 2019. I would like to introduce Members of the Board with us today.

Donovan Anderson. I'm Chairman of the Board. We

have five Members in attendance for the conduct

of business today and we have a quorum.

I would like to mention two things before we get started. First of all, if you have any electronic devices, pagers, cell phones or such, please, make certain that they are turned

off to avoid any interruption of the proceeding.

Secondly, there is a piece of paper on each table. When you come forward as your case is called, please, take a seat at the table and, please, sign-in. This is to ensure the correct spelling of your name for the record.

Additionally, when you introduce yourself for the record, please, spell your name aloud for the court reporter.

just saw was the swearing in of myself as Chair for another -- the Mayor appointed us and the City Council confirmed us to another four year term. Cause Hearing, since -- you should bring whatever

documents or witnesses that you have to defend

your position.

And one of the things I have asked both sides is seven days prior to that hearing is that you need to disclose documents and witnesses. So whatever documents and witnesses you are going to rely on at the hearing on September 11th at 9:00, I'm asking that both parties exchange those documents with each other, so they will know what documents and witnesses will appear at the hearing.

Are there any preliminary matters in this case?

MS. KRUPKE: There are. The parties have reached an Offer in Compromise to settle the charge of increase interior occupancy, a violation of DC Code 25-823(a)(7), which is a primary tier violation. It's the establishment's first primary tier violation and the offer is for a fine of \$1,250 to be payable within 30 days or the license shall be suspended indefinitely until the fine is paid.

CHAIRPERSON ANDERSON: All right.

Thank you. All right. Good morning again, Mr.

Amente. It's my understanding that there is an

Offer in Compromise and the Offer in Compromise

is that there is a fine of \$1,250 payable in 30

days. If the fine is not payable in 30 days, the

license will be suspended until the fine has been

paid.

1 Is this your understanding of the 2 Offer in Compromise? 3 MR. AMENTE: Yes. 4 CHAIRPERSON ANDERSON: Are you aware 5 that by accepting an Offer in Compromise, that you are giving up your right to a hearing? 6 7 MR. AMENTE: I'm sorry? 8 CHAIRPERSON ANDERSON: That by 9 accepting this offer, you are giving up your right to have a hearing? 10 11 MR. AMENTE: Yes. 12 CHAIRPERSON ANDERSON: Are you also 13 aware that by accepting this offer, you are 14 giving up your right to appeal this matter? 15 (No audible answer). MR. AMENTE: 16 CHAIRPERSON ANDERSON: Meaning that 17 was this ever explained to you that, okay, this 18 is what -- because I'm agreeing to this Offer in 19 Compromise, that I cannot contest it. That this 20 is what I'm agreeing to, I can't appeal it. Ι 21 can't change it. You can't change your mind 22 tomorrow to say well --
