4	on our calendar is Case No. 18-CMP-00244,
5	Ambassador Restaurant, License No. 90422.
6	Would the parties, please, approach
7	and identify themselves for the record, please?
8	MS. KRUPKE: Jessica Krupke on behalf
9	of the Government.
10	CHAIRPERSON ANDERSON: Good morning,
11	Ms. Krupke.
12	MR. KIDANE: I'm Romeseghed.
13	CHAIRPERSON ANDERSON: I'm sorry, your
14	name, sir?
15	MR. KIDANE: Romeseghed Kidane. I'm
16	the owner of the restaurant.
17	CHAIRPERSON ANDERSON: Mr. Kidane,
18	good morning, sir.
19	MR. KIDANE: Good morning.
20	CHAIRPERSON ANDERSON: All right.
21	Please, sign in on the sign-in sheet, please.
22	All right. Are there any preliminary

matters in this case?

MS. KRUPKE: There are. The parties have reached an Offer in Compromise. The offer is a total of \$5,000 paid within 90 days or the license shall be suspended indefinitely. That represents \$2,500 for Charge 1 and \$2,500 for Charge 2.

CHAIRPERSON ANDERSON: All right. Mr. Kidane, it's my understanding, sir, that there is an Offer in Compromise and the Offer in Compromise is that for Charge 1 there is a fine of \$2,500. For Charge 2 there is a fine of \$2,500 for a total fine of \$5,000 payable within 90 days. If the fine is not payable within 90 days, the license will be suspended until the fine has been paid.

Is this your understanding, sir, of the Offer in Compromise?

MR. KIDANE: Yes.

CHAIRPERSON ANDERSON: Are you aware that by accepting an Offer in Compromise, that you are giving up your right to a hearing?

2	CHAIRPERSON ANDERSON: Are you also
3	aware that by accepting an Offer in Compromise,
4	that you are giving up your right to appeal this
5	matter?
6	MR. KIDANE: Yes.
7	CHAIRPERSON ANDERSON: All right.
8	With that said, I make a motion that the Offer in
9	Compromise of a fine of \$2,500 for Charge 1,
10	\$2,500 for Charge 2, the total fine of \$5,000
11	will be paid within 90 days. If the fine is not
12	payable within 90 days, the license will be
13	suspended until the fine has been paid.
14	Is there a second?
15	MEMBER SILVERSTEIN: Second.
16	CHAIRPERSON ANDERSON: Mr. Silverstein
17	has seconded the motion.
18	All those in favor say aye.
19	ALL: Aye.
20	CHAIRPERSON ANDERSON: Those opposed?
21	The matter passed 5-0-0.
22	Thank you. I'll have you sign-off on

1	some paperwork. So the 90 days will start once
2	as of today. Thank you.
3	MS. KRUPKE: Thank you.
4	CHAIRPERSON ANDERSON: Thank you.
