ORDER APPROVING THE OFFER-IN-COMPROMISE

This matter arises from a Notice of Status and Show Cause Hearing (Notice) issued by the Alcoholic Beverage Control Board (Board) in the matter of Belay Abere, t/a Amsterdam Lounge (Respondent) located at 1208 U Street, NW, Washington, D.C. 20009.

The Alcoholic Beverage Regulation Administration (ABRA) served the Notice in Case No. 20-251-00010 on the Respondent on November 30, 2020. *ABRA Show Cause File No. 20-251-00010*. The Notice charges the Respondent with a single violation, which if proven true,

would justify the imposition of a fine, as well as the suspension or revocation of the Respondent's license.

Specifically, the Notice in Case No. 20-251-00010 charged the Respondent with the following violation:

Charge I: [On Sunday, January 5, 2020], you failed to follow your security plan by not having the correct number of cameras, in violation of D.C. Official Code § 25-823...

ABRA Show Cause File No. 20-251-00010, Notice of Status Hearing and Show Cause Hearing, 2 (May 14, 2020).

At the Show Cause Hearing held on December 9, 2020, the Respondent and the Government entered into an Offer-in-Compromise (OIC), which resolved the charge set forth above.

The terms of the OIC are as follows:

1. For Charge I – Warning.

By agreeing to the terms of the OIC, the Respondent hereby waives its right to a Show Cause Hearing and appeal.

ORDER

Therefore, the Board, on this 9th day of December 2020, hereby **APPROVES** the OIC proffered by the Government and the Respondent.

The Board hereby **ORDERS** that the Respondent be **WARNED** not to commit this offense again.

A copy of this Order shall be sent to the Respondent and to the Government.

Also, pursuant to section II of the District of Columbia Administrative Procedure Act, Pub. L. 90-614, 82 Stat. 1209, D.C. Official Code §2-510 (2001), and Rule 15 of the District of Columbia Court of Appeals, any party adversely affected has the right to appeal this Order by filing a petition for review, within thi1ty (30) days of the date of service of this Order, with the District of Columbia Cou1t of Appeals, 430 E Street, N.W., Washington, D.C. 20001; (202/879-1010). However, the timely filing of a Motion for Reconsideration pursuant to 23 DCMR §1719.1 (2008) stays the time for filing a petition for review in the District of Columbia Court of Appeals until the Board rules on the motion.
