**ORDER GRANTING PETITIONER'S MOTION FOR RECONSIDERATION
AND REINSTATEMENT OF LICENSE**

On May 15, 2019, the Alcoholic Beverage Control Board (Board) cancelled the Retailer Class CR License ABRA-106151 held by 5534 Connecticut, LLC, t/a Arucola, because 5534 Connecticut, LLC failed to renew its license by March 31, 2019. *See* Board Order No. 2019-412.

On May 28, 2019, Sidon Yohannes, Esq., on behalf of 5534 Connecticut, LLC (Petitioner), sought reinstatement of the Retailer's Class CR License ABRA-106151. In support of her Motion for Reconsideration, Ms. Yohannes stated that the Petitioner was unable to renew its license due to outstanding taxes owed to the Office of Tax and Revenue (OTR) and additional issues with the Department of Employment Services (DOES). Ms. Yohannes now informs the Board that the Petitioner's financial situation has been resolved and it wants to resume the operation of its business.

The Board finds that the reinstatement of the license is proper conditioned upon the requirement that the Petitioner renews its license and pays the required fees.


Accordingly, it is this 5th day of June, 2019, **ORDERED** that the **ORDER CANCELLING LICENSE** issued against 5534 Connecticut, LLC, t/a Arucola, by the Board on May 15, 2019, be and hereby is **VACATED**.

IT IS FURTHER ORDERED that the Retailer's Class CR License ABRA-106151 be **REINSTATED**.


IT IS FURTHER ORDERED that the Petitioner renew and pay the required fees within two (2) weeks from the date of this Order.

Pursuant to D.C. Official Code § 25-433(d)(1), any party adversely affected may file a Motion for Reconsideration of this decision within ten (10) days of service of this Order with the Alcoholic Beverage Regulation Administration, 2000 14th Street, N.W., Suite 400S, Washington, DC 20009.

Also, pursuant to section 11 of the District of Columbia Administrative Procedure Act, Pub. L. 90-614, 82 Stat. 1209, D.C. Official Code §2-510 (2001), and Rule 15 of the District of Columbia Court of Appeals, any party adversely affected has the right to appeal this Order by filing a petition for review, within thirty (30) days of the date of service of this Order, with the District of Columbia Court of Appeals, 430 E Street, N.W., Washington, D.C. 20001; (202/879-1010). However, the timely filing of a Motion for Reconsideration pursuant to 23 DCMR §1719.1 (2008) stays the time for filing a petition for review in the District of Columbia Court of Appeals until the Board rules on the motion. See D.C. App. Rule 15(b) (2004).
