On September 17, 2021, the Alcoholic Beverage Regulation Administration's (ABRA) Enforcement Division determined that SST Management, LLC, t/a BIN-1301, was out of business.

On September 17, 2021, an ABRA Investigator visited the establishment and spoke with Chai Morales, Building Manager for The Ellington, and landlord of the licensed premises. Ms. Morales confirmed that the establishment has been closed for approximately three (3) business days and the Licensee returned the keys to the premises.

It is hereby **ORDERED** on this 20th day of October 2021, that SST Management, LLC's License No. ABRA-091682 is **CANCELLED**. A copy of this Order shall be sent to the Licensee.

Pursuant to D.C. Official Code § 25-433(d)(1), any party adversely affected may file a Motion for Reconsideration of this decision within ten (10) days of service of this Order with the Alcoholic Beverage Regulation Administration, 2000 14<sup>th</sup> Street, N.W., Suite 400S, Washington, DC 20009.

Also, pursuant to section II of the District of Columbia Administrative Procedure Act, Pub. L. 90-614, 82 Stat. 1209, D.C. Official Code §2-510 (2001), and Rule 15 of the District of Columbia Court of Appeals, any party adversely affected has the right to appeal this Order by filing a petition for review, within thirty (30) days of the date of service of this Order, with the District of Columbia Court of Appeals, 430 E Street, N.W., Washington, D.C. 20001; (202/879- 1010). However, the timely filing of a Motion for Reconsideration pursuant to 23 DCMR §1719.1 (2008) stays the time for filing a petition for review in the District of Columbia Court of Appeals until the Board rules on the motion. See D.C. App. Rule 15(b) (2004).
