Will the parties please approach and 6 7 identify themselves for the record, please. MR. ORTIZ: Steven Ortiz on behalf of 8 9 the District of Columbia. CHAIRPERSON ANDERSON: Mr. Ortiz. 10 11 MR. LEE: Good morning, Board Members. 12 My name is Kevin Lee and I'm representing BBDC 1, LLC, trade name, Bareburger. 13 14 CHAIRPERSON ANDERSON: Good morning, 15 Are there any preliminary matters in Mr. Lee. 16 this case? 17 Yes, there is a MR. ORTIZ: 18 preliminary matter. As to Charge 1, no ABC 19 manager, the OIC is that the establishment shall 20 pay \$2000 within 30 days or its license shall be 21 suspended indefinitely until this fine is paid.

As to Charge 2, which is failure to have posted window lettering, this -- the offer in compromise is a mandatory warning.
