3 CHAIRPERSON ANDERSON: The next case
4 on our calendar is Case No. 19-CMP-00196,
5 Bareburger, License No. 102759.

6 Will the parties please approach and
7 identify themselves for the record, please?

8 MR. FACCI: Jason Facci on behalf of
9 the District.

10 CHAIRPERSON ANDERSON: Good morning,
11 Mr. Facci.

12 MR. FACCI: Good morning.

13 MR. LEE: Good morning, Board members.
14 My name is Kevin Lee, representing BBDC 1, LLC,
15 Bareburgers.

16 CHAIRPERSON ANDERSON: Good morning,
17 Mr. Lee.

18 MR. LEE: Good morning.

19 CHAIRPERSON ANDERSON: Are there any
20 preliminary matters in this case?

21 MR. FACCI: Yes, Mr. Chairman. We do
22 have an offer in compromise.

23 CHAIRPERSON ANDERSON: And what is
24 that, please?

25 MR. FACCI: Regarding Charge 1, no ABC

1 manager, a \$2,000 fine to be paid within 30 days
2 or the license shall be suspended indefinitely
3 until the fine is paid.

4 CHAIRPERSON ANDERSON: Thank you, Mr.
5 Facci.

6 Mr. Lee, it's my understanding that
7 there is an offer in compromise and the offer and
8 compromise is that there is a fine of \$2,000
9 payable within 30 days. If the fine is not paid
10 within 30 days, the license will be suspended.

11 Is this your understanding of the
12 offer, you and your client's understanding of the
13 offer in compromise?

14 MR. LEE: Yes, we understood that.

15 CHAIRPERSON ANDERSON: All right. Now
16 are both you and your client under the
17 understanding that by accepting an offer in
18 compromise, that you are giving up your right to
19 a hearing?

20 MR. LEE: Yes, I'll accept that --

21 CHAIRPERSON ANDERSON: And is both,
22 are also both you and your client, are you aware
23 that by accepting an offer in compromise, that
24 you are giving up your right to have a hearing?

25 MR. LEE: Yes, they are aware of that.

1 CHAIRPERSON ANDERSON: All right, with
2 that said, I make a motion that the offer in
3 compromise of a fine of \$2,000 payable within 30
4 days be accepted.

5 If the fine is not paid within 30
6 days, the license will be suspended until the
7 fine has been paid.

8 Is there a second?

9 MEMBER SHORT: Second.

10 CHAIRPERSON ANDERSON: Mr. Short has
11 seconded the motion.

12 All those in favor say aye.

13 (Chorus of aye.)

14 CHAIRPERSON ANDERSON: Those opposed?

15 The matter passed 7-0-0.

16 MR. FACCI: Thank you.

17 MR. LEE: Thank you very much.

18 CHAIRPERSON ANDERSON: All right.
