3	CHAIRPERSON ANDERSON: All right.
4	Let's move to our Show Cause Hearing (Status)
5	Calendar. The first case on our Show Cause
6	Hearing (Status) Calendar is Case No. 19-AUD-
7	00014, Benito's Place, License No. 106428.
8	Will the parties, please, approach and
9	identify themselves for the record, please?
10	MS. MARKS: Good morning, Mr.
11	Chairman. Lindsay Marks for the District of
12	Columbia.
13	CHAIRPERSON ANDERSON: Good morning,
14	Ms. Marks. And your name, sir?
15	MR. MAJANO: My name is Mainor Majano.
16	I am the owner from Benito's Place.
17	CHAIRPERSON ANDERSON: Good morning,
18	sir.
19	Are there any preliminary matters in
20	this case?
21	MS. MARKS: Yes, Mr. Chairman. The
22	parties have an Offer in Compromise for the Board

1	today.
2	CHAIRPERSON ANDERSON: And what is
3	that, please?
4	MS. MARKS: For Charge 1 a fine of
5	\$600 to be paid within 30 days or the license
6	should be suspended indefinitely until the fine
7	is paid.
8	And to also submit any pending
9	quarterly statements that are outstanding.
10	CHAIRPERSON ANDERSON: Okay. Is there
11	a time line to produce those?
12	MS. MARKS: I believe in 30 days as
13	well.
14	CHAIRPERSON ANDERSON: It's my
15	understanding that no quarterly statement was
16	filed for the entire year, so there are four
17	statements that are due.
18	MS. MARKS: I am not certain, at this
19	point, how many are still outstanding. Perhaps
20	the owner would be able to speak to that?
21	CHAIRPERSON ANDERSON: All right.
22	It's my understanding that there is an Offer in

1	Compromise and the Offer in Compromise is that
2	there is a fine of \$600 payable within 30 days
3	and all outstanding quarterly statements will be
4	filed within 30 days.
5	Is this your understanding, sir, of
6	the Offer in Compromise?
7	MR. MAJANO: (No audible answer.)
8	CHAIRPERSON ANDERSON: You have to
9	I have to hear you say yes or no.
10	MR. MAJANO: Yes, I accept, yes.
11	CHAIRPERSON ANDERSON: All right. Are
12	you aware that by accepting an Offer in
13	Compromise, that you are giving up your right to
14	a hearing?
15	MR. MAJANO: Yes, sir.
16	CHAIRPERSON ANDERSON: Are you also
17	aware that by accepting an Offer in Compromise,
18	that you are giving up your right to appeal this
19	matter?
20	MR. MAJANO: Yes.
21	CHAIRPERSON ANDERSON: With that said,
22	I make a motion that the Offer in Compromise of a

1 fine of \$600 payable within 30 days, that all 2 outstanding quarterly statements also be filed within 30 days. If this is not done, the license 3 4 will be suspended until the fine has been paid 5 and the quarterly statements have been paid -have been filed. 6 Is there a second? 7 8 MEMBER SHORT: Second. 9 CHAIRPERSON ANDERSON: Mr. Short has seconded the motion. 10 11 All those in favor say aye. 12 ALL: Aye. 13 CHAIRPERSON ANDERSON: Those opposed? The matter passes 4-0-0. 14 We will have you sign-off on the 15 16 paperwork, sir. 17 Now that the case is over, it's my 18 understanding that there are four quarterly 19 statements that need to be filed. If you need 20 some assistance in filing the quarterly 21 statements, the Agency is aware to help you and

provide you the guidance, sir.
