3 MS. FLETCHER: Would the parties in
4 the matter of Best 1 Liquor please come forward,
5 the parties in the matter of Best 1 Liquor?

6 This is Case Number 19-PRO-00114,
7 Sunny Ventures, LLC, 322 Florida Avenue NW,
8 License Number ABRA-109545. This is a Retailer
9 Class A substantial change, changes of hours of
10 operation and alcoholic beverage sales.

11 My name is LaVerne Fletcher,
12 conducting the roll call hearing as the Board's
13 agent. Is the Applicant present today, the
14 Applicant in the matter of Best 1 Liquor?

15 (No audible response.)

16 MS. FLETCHER: Present on behalf of
17 ANC 5E?

18 MS. LEWIS: Yes, Karla M. Lewis.

19 MS. FLETCHER: Ms. Lewis would you
20 spell your name please?

21 MS. LEWIS: K-A-R-L-A M. L-E-W-I-S.

22 MS. FLETCHER: And there's also a
23 group of eight individuals present on behalf of
24 that group.

25 MR. MILLER: Just me today

1 representing the group.

2 MS. FLETCHER: And if you could just
3 state your name and spell it for the record,
4 please.

5 MR. MILLER: My name is Heath Miller,
6 H-E-A-T-H M-I-L-L-E-R.

7 MS. FLETCHER: Heath Miller. Okay,
8 Mr. Miller, can you spell your first name again?

9 MR. MILLER: H-E-A-T-H.

10 MS. FLETCHER: Oh, okay, thank you.
11 Okay, Mr. Miller. The group that you represent
12 is granted conditional standing today. Four more
13 people from your group will need to appear at the
14 upcoming status hearing. And at that time, the
15 ABC Board will grant full standing to the group.

16 You are part of a group of eight. So
17 the group of eight is granted conditional
18 standing. And Ms. Lewis, ANC 5E is granted
19 standing.

20 Is the Applicant present?

21 (No audible response.)

22 MS. FLETCHER: The time is
23 approximately 10:20. The Applicant is not
24 present. The application for a substantial
25 change is dismissed.

1 The Board is going to issue the order
2 dismissing the application. You're going to get
3 a copy of it. Mr. Miller, did you put your
4 contact information on that sheet?

5 MR. MILLER: Yes, I did.

6 MS. FLETCHER: Okay, because that
7 Board order is going to be by email. If the
8 Applicant seeks reinstatement of that
9 application, you'll be kept informed. And you'll
10 have an- opportunity to be opposed to the
11 reinstatement of the application. But the
12 application is dismissed as of today.

15 that, Mr. Miller?

16 MR. MILLER: No.

17 MS. FLETCHER: Okay. Well, then thank
18 you for coming.
