

**ORDER VACATING BOARD ORDER NO. 2019-319**




On this 15th day of May 2019, the Alcoholic Beverage Control Board **VACATES** Board Order No. 2019-319 and permits the return of the above mentioned license to the license holder. The Board received documentation after the issuance of the Order showing that the tax matter at issue is currently being adjudicated by the Office of Administrative Hearings (OAH). Out of comity to OAH and, in light of D.C. Official Code § 47-2862(c), the Board will vacate the prior order vacating the license holder's renewal and ordering the surrender of the license. The Board advises the license holder that, should the facts continue to warrant such an action, the Board may reinstate Board Order No. 2019-319 and order the surrender of the license once OAH finishes its adjudication. A copy of this Order shall be provided to the license holder.

Pursuant to D.C. Official Code § 25-433(d)(1), any party adversely affected may file a Motion for Reconsideration of this decision within ten (10) days of service of this Order with the Alcoholic Beverage Regulation Administration, Reeves Center, 2000 14th Street, NW, 400S, Washington, D.C. 20009.

Also, pursuant to section 11 of the District of Columbia Administrative Procedure Act, Pub. L. 90-614, 82 Stat. 1209, D.C. Code § 2-510 (2001), and Rule 15 of the District of Columbia Court of Appeals, any party adversely affected has the right to appeal this Order by filing a petition for review, within thirty (30) days of the date of service of this Order, with the District of Columbia Court of Appeals, 430 E Street, N.W., Washington, D.C. 20001. However, the timely filing of a Motion for Reconsideration pursuant to 23 DCMR § 1719.1 stays the time for filing a petition for review in the District of Columbia Court of Appeals until the Board rules on the motion. *See* D.C. App. Rule 15(b) (2004).
