ORDER GRANTING REINSTATEMENT OF APPLICATION

The Application filed by Bodega Market, LLC, t/a Bodega Market (Applicant), for renewal of its Retailer's Class A License, having been protested, came before the Alcoholic Beverage Control Board (Board) for a Roll Call Hearing on June 11, 2018, and a Protest Status Hearing on July 25, 2018.

On July 25, 2018, the Board dismissed the Application, because the Applicant failed to appear at the Protest Status Hearing. *See* Board Order 2018-469.

On July 30, 2018, Jared Demissie, owner, filed a request for reinstatement. Mr. Demissie explained that he did not appear at the Protest Status Hearing because he mistakenly believed that when he and ANC 5D had entered into a signed Settlement Agreement, it was not necessary to attend the Protest Status Hearing. Mr. Demissie seeks the reinstatement of his Application so that the license can be renewed.

Upon consideration of this request to reinstate the Application, the Board finds that the Applicant's request constitutes good cause to reinstate the Application pursuant to 23 DCMR 1602.3.

ORDER

For these reasons, the Board does hereby, this 1st day of August, 2018, **REINSTATE** the Application filed by Bodega Market, LLC, t/a Bodega Market, for renewal of its Retailer's Class A License. Copies of this Order shall be sent to the Applicant.

However, the timely filing of a Motion for Reconsideration pursuant to 23 DCMR §1719.1 (2008) stays the time for filing a petition for review in the District of Columbia Court of Appeals until the Board rules on the motion.
