### ORDER ON FOURTH AMENDMENT TO SETTLEMENT AGREEMENT

The official records of the Alcoholic Beverage Control Board (Board) reflect that Boomerang Boat Tour, LLC, located at 1300 Maine Avenue, SW, Washington, D.C., and ANC 6D entered into a Voluntary Agreement (Agreement), dated October 18, 2010, a First Amendment to Voluntary Agreement (Amendment), dated January 10, 2011, a Second Amendment to Settlement Agreement (Second Amendment), dated October 15, 2012, and a Third Amendment to Settlement Agreement (Third Amendment), February 9, 2015, that governs the operation of the Licensee's establishment. This matter comes now before the Board to consider the Parties' Fourth Amendment to Settlement Agreement (Fourth Amendment), dated April 9, 2018, in accordance with D.C. Official Code § 25-446 (2001).

The Fourth Amendment has been reduced to writing and has been properly executed and filed with the Board. The Licensee and Chairperson Meredith Fascett and Dr. Coralie Farlee, on behalf of ANC 6D, are signatories to the Fourth Amendment.

# FOURTH AMENDMENT TO VOLUNTARY AGREEMENT

This Fourth Amendment to Voluntary Agreement is made on this 9<sup>th</sup> day of April, 2018, by and between Boomerang Boat Tours LLC ("the Licensee"), ABRA # 085705 and Advisory Neighborhood Commission 6D ("the ANC").

#### WITNESSETH

WHEREAS, the parties entered into an Amended Cooperative/Voluntary Agreement dated January 11, 2011, governing certain aspects of the Licensee's operations; and,

WHEREAS, the parties desire to further amend said Amended Voluntary/Cooperative Agreement hereby to provide for transfer of the location of the vessel trading as The Boomerang Boat to 1300 Maine Avenue, SW, Washington, DC 20024, where the other two vessels on the License are already berthed and to update the trade names of the licensed vessels;

NOW, THEREFORE, in consideration of the recitals set forth above and the terms and conditions provided below, the parties agree as follows:

1. The first preamble ("WHEREAS") of the January 10, 2011, Amended Voluntary/Cooperative Agreement is amended to read in its entirety:

"WHEREAS, Applicant has applied for a Retailers Class CX Common Carrier (Marine Vessel) license for three (3) marine vessels operating under Boomerang Boat Tours LLC as (i) the Boomerang Boat (capacity of 74 passengers), berthed at 1300 Maine Avenue, SW, Washington, DC; (ii) Boomerang Pirate Boat (99 passengers), berthed at 1300 Water Street, SW, Washington, DC; and (iii) Boomerang Yacht (149 passengers), berthed at 1300 Water Street, SW, Washington, DC; "

2. All references in the preambles or text of the January 10, 2011 Amended Voluntary/Cooperative Agreement to "Boomerang Boat II" are amended hereby to read "Boomerang Pirate Boat."

3. In Paragraph 3, "Noise and Privacy", lines 5-6, the phrase "... and shut off 5 minutes prior to landing ..." shall be changed to read "Sound on the vessel shall be reduced when exiting and entering the Washington Channel, Georgetown and Anacostia River areas. Sound on the vessel shall be shut off 15 minutes prior to landing and while at dockside in the Washington Channel and Anacostia areas; and 5 minutes prior to landing and while at dockside in the Georgetown area...

4. All references in Section 10 ("Notice") to the Licensee's mailing address of "2909 Olive Street, NW" are amended hereby to reflect "1072 31" Street, NW."

5. Except as explicitly amended herein, all terms and conditions of the January 10, 2011 Amended Voluntary/Cooperative Agreement between the parties remain in full force and effect and unmodified.
