Resolution Regarding An Amended Settlement Agreement between ANC3B and F&B LLC t/a Breadsoda

Breadsoda, a restaurant located at 2233 Wisconsin Avenue in Glover Park, ABRA License #78085, has requested two changes in its existing Settlement Agreement, dated May 14, 2012, to allow full hours on its street-level summer garden and to allow the use of speakers for ambient music on both its street-level and below-grade outdoor spaces.

The active Settlement Agreement attached to Breadsoda's location and its liquor license also names the previous owner of the establishment. The amended agreement is updated to reflect the names of the current owners.

Breadsoda presented its request at a duly noticed public meeting of ANC3B on May 13. 2021, at which time a comment period was opened so that nearby residents could advise the ANC of any concerns with the proposed changes. All comments received were supportive of the changes and of Breadsoda's operation.

ANC3B hereby resolves to approve the amended Settlement Agreement and to submit it to the Alcoholic Beverage Control Board for its approval.

This resolution was approved by a vote of 5-0 at a duly noticed public meeting on June 10, 2021, at which a quorum was present. (Three of the five members constitute a quorum.)

By this vote, the Commission also designates Commissioner Blumenthal or her designee to represent the Commission on all matters pertaining to this resolution.

AMENDED SETTLEMENT AGREEMENT Glover Park F&B LLC t/a Breadsoda ABRA Lic. #78085

WHEREAS, Glover Park F&B LLC t/a Breadsoda ("Breadsoda"), through its principals Steve Teague and Dominick Garzaniti, has requested changes to the Settlement Agreement attached to Class CR license #78085;

WHEREAS, ANC3B has received no complaints or concerns about the operations of Breadsoda located at 2233 Wisconsin Avenue since its original Settlement Agreement was signed on May 4, 2008 and amended on May 14, 2012;

WHEREAS, ANC3B has requested community comment on the following changes to closing times and entertainment, and has received no objections provided that the restrictions contained below remain in effect:

THEREFORE, ANC3B and Breadsoda agree to amend the terms and restrictions of the May 14, 2012 Settlement Agreement as follows:

- 1. Breadsoda will at all times operate as a bona fide restaurant.
- 2. Breadsoda's closing times will conform to the maximum allowable under current ABRA regulations, including its street-level summer garden, subject to the restrictions contained in this agreement.
- 3. This agreement does not prevent Breadsoda from taking advantage of special holiday closing times as provided by ABRA.
- 4. Breadsoda will make all efforts to ensure that patrons in the street-level summer garden remain seated.
- 5. At all times, Breadsoda will make all reasonable efforts to prevent patrons from engaging in loud or disruptive conduct both on the premises and as they depart into the neighborhood.
- 6. Breadsoda will advise its patrons that they can park for free in the 2233 Wisconsin Avenue rear parking lot after 7 p.m.
- 7. Breadsoda may offer recorded music as background for dining at all times. Breadsoda may provide live acoustic music and/or live DJ performances no more than once a week. Any such entertainment, however, shall be consistent with the character of

the premises as an eating establishment and shall terminate at least one-half hour before closing time.

- 8. Breadsoda will not allow any entertainment, whether live or recorded, to be audible at its property line. Any speakers placed in its summer gardens must be regulated to contain the sound within the premises.
- 9. This agreement shall be binding upon any person to whom the license is sold, transferred or assigned.

The above nine paragraphs constitute the full extent of the Settlement Agreement and replace in total the previous agreement between ANC3B and Breadsoda, which was dated May 14, 2012.
