4	the matter of Buzzard Point Fish House, please,
5	come forward? This is Case No. 18-PRO-00083.
6	DR. FARLEE: 18-PRO what?
7	AGENT FLETCHER: 00083.
8	DR. FARLEE: Okay.
9	AGENT FLETCHER: That's 18-PRO
10	DR. FARLEE: Yeah.
11	AGENT FLETCHER: three zeros
12	DR. FARLEE: Yeah.
13	AGENT FLETCHER: and then 83.
14	DR. FARLEE: Got it.
15	AGENT FLETCHER: Greenleaf Buzzard,
16	LLC, 2100 2nd Street, S.W., License No. ABRA-
17	111655. This is a Retailer Class CR new
18	application.
19	The protest issues are adverse impact
20	on peace, order and quiet; residential parking
21	and vehicular and pedestrian safety.
22	My name is LaVerne Fletcher conducting

1	the Roll Call Hearing as the Board's Agent.
2	Introductions beginning with the
3	applicant, please.
4	MS. YOHANNES: Sidon Yohannes on
5	behalf of the applicant.
6	AGENT FLETCHER: Ms. Yohannes, would
7	you spell your name for the record?
8	MS. YOHANNES: S-I-D-O-N Y-O-H-A-N-N-
9	E-S.
10	AGENT FLETCHER: And on behalf of ANC-
11	6D?
12	DR. FARLEE: Coralie Farlee, C-O-R-A-
13	L-I-E F-A-R-L-E-E. What else do you want?
14	AGENT FLETCHER: Thank you, Dr.
15	Farlee, that's good.
16	ANC-6D does have standing as a
17	protestant.
18	We need to set a date for a mediation,
19	a Status Hearing and a Protest Hearing. I will
20	give you the date for the Status and Protest
21	Hearing first.
22	The Status Hearing is set for January

1 16, January 16, 2019, at 9:30. 2 And the Protest Hearing is set for February 13, February 13, 2019, at 1:30. 3 4 I will give you the next available 5 date for mediation. The next available day for 6 mediation is Tuesday, January 8th, that's Tuesday, January 8 at 9:00, 10:00, 11:00, 12:00, basically 7 8 any time on Tuesday, January 8. 9 MS. YOHANNES: I am not available. 10 DR. FARLEE: Yeah, well, I'm supposed 11 to be out of town, but also --AGENT FLETCHER: What about the -- I'm 12 13 sorry? 14 DR. FARLEE: -- I'm not sure we are going to need one. 15 16 AGENT FLETCHER: What we can do, we 17 can just set it. I'll make a note that we may 18 not need it and then if you settle before then, 19 we will just cancel it. 20 But let me ask you this, Dr. Farlee, 21 what about are you available Monday, January 7 or that whole week not any good? 22

5	MS. YOHANNES: I would request
6	something the following week.

9	DR. FARLEE: No.
10	AGENT FLETCHER: We can do Tuesday,
11	January 15th. The Status Hearing is the 16th. You
12	know already that if for some reason we can't do
13	it before the Status Hearing, we will just do it
14	after.
15	DR. FARLEE: Yeah.
16	AGENT FLETCHER: Because
17	DR. FARLEE: Let's leave it open. I
18	feel I think there is not much point in having
19	a mediation
20	AGENT FLETCHER: Um-hum.
21	DR. FARLEE: session.
22	AGENT FLETCHER: Would you agree with

1	that? So here is the thing. So what I need to
2	do is set a date, if you don't come at all, just
3	because I just have to put a date out there.
4	But, Dr. Farlee, I'll make a note that it may not
