The Alcoholic Beverage Control Board met in the Alcoholic Beverage Control Hearing Room, Reeves Building, 2000 14th Street, N.W., Suite 400S, Washington, D.C. 20009, Chairperson Donovan W. Anderson, presiding.

3 AGENT FLETCHER: Would the parties in
4 the matter of 701 Second Street, LLC t/a Cafe
5 Fili, please, come forward? This is Case No. 18-
6 PRO-00078, 701 2nd Street, N.E., License No. ABRA-
7 110971. This is a Retailer Class CR new
8 application.

9 The protest issues are adverse impact
10 on peace, order and quiet, residential parking
11 and vehicular and pedestrian safety and real
12 property values.

13 My name is LaVerne Fletcher. I'm
14 conducting the Roll Call Hearing as the Board's
15 Agent.

16 Introductions beginning with the
17 applicant, please.

18 MS. YOHANNES: Sidon Yohannes on
19 behalf of the applicant.

20 AGENT FLETCHER: Ms. Yohannes, would
21 you spell your name for the record, please?

22 MS. YOHANNES: Sure. S-I-D-O-N

1 Yohannes, Y-O-H-A-N-N-E-S.

2 AGENT FLETCHER: Thank you very much.

3 And present on behalf of ANC-6C?

4 MR. ECKENWILER: Mark Eckenwiler, Vice
5 Chair, ANC-6C. That's Mark, M-A-R-K, last name
6 E-C-K-E-N-W-I-L-E-R.

7 AGENT FLETCHER: Thank you very much,
8 Mr. Eckenwiler.

9 ANC-6C does have standing as a
10 protestant.

11 We need to set a date for mediation,
12 a Status Hearing and Protest Hearing. I'll give
13 you the date for the Status and Protest Hearing
14 first.

15 The Status Hearing is set for January
16 9, 2019 at 9:30 a.m.

17 MR. ECKENWILER: Excuse me, that's a
18 Wednesday?

19 AGENT FLETCHER: That's -- I'll tell
20 you.

21 MR. ECKENWILER: I think it's a
22 Wednesday.

1 AGENT FLETCHER: Is that a Wednesday?
2 Yeah.

3 MR. ECKENWILER: Okay. That's fine.
4 That's fine for me.

5 AGENT FLETCHER: Oh, yeah, the Status
6 Hearing, it will be on Wednesday.

7 The Status Hearing will be on a
8 Wednesday. Okay. And the Protest Hearing is on
9 January 30. January 30, 2019 at 4:30 p.m.

10 We need to set a date for mediation.
11 I'll give you the next available day. The next
12 available day for mediation is Tuesday, December
13 11 at 9:00, 10:00, 10:30, 11:00, 11:30, 1:00,
14 2:00?

15 MS. YOHANNES: I can do any time. No,
16 I cannot. Sorry, I can do any time after 10:30.

17 AGENT FLETCHER: Okay.

18 MR. ECKENWILER: So I have an
19 obligation from elsewhere from 10:00 to, in
20 theory, 11:30 or so. I'm sorry, what were the
21 other times that you offered?

22 AGENT FLETCHER: The other times were

1 9:00 and 10:00.

2 MR. ECKENWILER: I can do -- well, no,
3 wait. I'm sorry, Ms. Yohannes said she can't do
4 9:00 a.m.

5 MS. YOHANNES: Right, yes.

6 MR. ECKENWILER: Okay. Then --

7 AGENT FLETCHER: Okay.

8 MR. ECKENWILER: -- I think that
9 morning is not going to work.

10 AGENT FLETCHER: Then we can do -- so
11 here is -- so we can also do, just so you know,
12 Monday, December 10, in the afternoon at 2:00. I
13 just wanted to give you that option before I
14 moved to the following week.

15 MS. YOHANNES: That works for me.

16 MR. ECKENWILER: I can do that.

17 AGENT FLETCHER: You can do that?

18 MR. ECKENWILER: Yes.

19 AGENT FLETCHER: 2:00 on December 10?

20 MS. YOHANNES: Yes.

21 MR. ECKENWILER: December 10, yeah.

22 AGENT FLETCHER: So mediation is set

1 for 2:00 on December 10.

2 Mr. Eckenwiler, did you already put
3 your email address on that contact sheet?

4 MR. ECKENWILER: I have done that and
5 I have also given my card to the reporter.

6 AGENT FLETCHER: Okay. Thank you very
7 much.

8 Okay. Well, then if there are no
9 questions, the Roll Call Hearing is concluded.

10 MS. YOHANNES: Thank you.

11 AGENT FLETCHER: And I'll see you
12 soon. Okay. Thank you.
