3 CHAIRPERSON ANDERSON: The next case
4 on our calendar is Case No. 18-CIT-00106, Chaia,
5 LLC, License No. 99787.

6 Ms. Gephardt, is there a preliminary
7 matter in this case?

8 MS. GEPHARDT: Yes, there is. The
9 parties have agreed on an Offer in Compromise to
10 include a \$350 fine to be paid within 30 days.
11 If the fine is not paid within 30 days, the
12 license would be suspended immediately until the
13 fine is paid.

14 CHAIRPERSON ANDERSON: All right.
15 Thank you. Ms. Revers, again, it's my
16 understanding that there is an Offer in
17 Compromise and the Offer in Compromise for this
18 case is that there is a fine of \$350 payable
19 within 30 days. If the fine is not payable in 30
20 days, the license will be suspended until the
21 fine has been paid.

22 Is this your understanding of the

1 Offer in Compromise?

2 MS. REVERS: Yes.

3 CHAIRPERSON ANDERSON: Are you aware
4 that by accepting an Offer in Compromise, that
5 you are giving up your right to a hearing?

6 MS. REVERS: Yes.

7 CHAIRPERSON ANDERSON: Are you also
8 aware that by accepting an Offer in Compromise,
9 you are giving up your right to appeal this
10 matter?

11 MS. REVERS: Yes.

12 CHAIRPERSON ANDERSON: With that said,
13 I make a motion that the Offer in Compromise of a
14 fine of \$350 payable in 30 days be accepted. If
15 the fine is not payable in 30 days, the license
16 will be suspended until the fine has been paid.
17 Is there a second?

18 MEMBER ISAAC: Second.

19 CHAIRPERSON ANDERSON: Mr. Isaac has
20 seconded the motion.

21 All those in favor say aye.

22 ALL: Aye.

1 CHAIRPERSON ANDERSON: Those opposed?
2 The matter passes 7-0-0.

3 Thank you very much. We will have you
4 sign-off on the paperwork, please. All right.
5 Thank you. You can step back and sign that.
