CHAIRPERSON ANDERSON: All 6 Okay. Ms. Reeden, it's my understanding that 7 right. 8 there is an Offer in Compromise and the Offer in 9 Compromise is that there is a fine of \$350 payable in 30 days. If the fine is not payable 10 11 in 30 days, the license will be suspended until 12 compliance has been made. 13 Is this your understanding of the 14 Offer in Compromise? 15 MS. BUSSEY-REEDEN: Yes, it is. 16 CHAIRPERSON ANDERSON: Are you aware 17 that by accepting an Offer in Compromise, that you are giving up your right to a hearing? 18 19 MS.
