CHAIR ANDERSON: We're back on the record. Our first matter is a public hearing on our civil penalty rulemaking.

We're here today pursuant to DC Official Code Section 25-830 to conduct a public hearing and take comment on a proposed rulemaking that amends the existing ABRA civil penalty schedule, set in Section 800 of Title 23 of the District of Columbia Municipal Regulations. The civil penalty schedule was last updated in July 2018.

The proposed rules are intended to update the existing schedule by, one, including new infractions and penalties, two, removing duplicate infractions, and three, amending the descriptions of existing of existing infractions.

By way of background, the Board approved the civil penalty schedule notice of proposed rulemaking on September 11, 2019, 4-0. On October 25, 2019, the proposed rulemaking was published in the DC Register for notice and public comment, see 66-DCR-14095 October 25, 2019.

1 ABRA did not receive any notification
2 from witnesses in advance of today's hearing
3 regarding their desire to address the Board.
4 Therefore, the Board will entertain comments from
5 anyone present today who wishes to be heard.
6 Please limit your comments to no more than five
7 minutes. If there is any time left, we will

10 testify on the civil penalty schedule?
