3 AGENT FLETCHER: Would the parties in
4 the matter of Club Cinema please come forward?
5 This is Case Number 19-PRO-00153, Club Cinema of
6 Mazza, Inc., 5300 Wisconsin Avenue, NW, License
7 Number ABRA-060040. This is a Retailer Class CT
8 Petition to Amend or Terminate the Settlement
9 Agreement. The protest issues are adverse
10 impact on peace, order, and quiet. My name is
11 Laverne Fletcher conducting the Roll Call Hearing
12 as the Board's agent. Introductions beginning
13 with the applicant, please?

14 MR. MINORA: Matthew Minora from the
15 law firm of Mallios & O'Brien on behalf of the
16 licensee.

17 AGENT FLETCHER: Thank you, Mr.
18 Minora. Would you spell your name for the
19 record, please?

20 MR. MINORA: Sure, Matthew, M-A-T-T-H-
21 E-W, Minora, M-I-N-O-R-A.

22 AGENT FLETCHER: Thank you. Agency 3E
23 is the protestant in this matter, but they are
24 not present today, but they were granted
25 conditional standing with an agreement and

1 understanding between the parties, the applicant,
2 and our general counsel. And so they're granted
3 conditional standing although they are not
4 present today.

5 Mr. Minora, let me ask you something.
6 Is it your understanding that there's going to be
7 a mediation still?

8 MR. MINORA: I believe so, correct.

9 AGENT FLETCHER: I'll go ahead and
10 give you the dates.

11 MR. MINORA: Yes, please.

12 AGENT FLETCHER: And then I'll provide
13 them to them later on today. So the date for
14 the status hearing is February 5, February 5,
15 2020 for the status hearing. That's at 9:30 a.m.
16 The protest hearing is set for March 11, 2020 at
17 1:30 p.m. That's March 11. Mr. Minora, I'm just
18 going to give you -- set a date with you for
19 medication to see if it's okay with the other
20 side.

21 (Pause.)

22 AGENT FLETCHER: The next available
23 day for mediation is Tuesday, January 21 at 1 or
24 2 in the afternoon.

25 MR. MINORA: Sure. We can do that at

1 2.

2 AGENT FLETCHER: At 2? Mediation is
3 set for 2:00 on January 21st. And so Mr. Minora,
4 I'll send this date to ANC3E. If that works,
5 we'll do it then. If not, we'll just set a
6 different date.

7 MR. MINORA: Okay.

8 AGENT FLETCHER: Okay. Thanks for
9 coming.

10 MR. MINORA: Thank you, appreciate it.

11 AGENT FLETCHER: Okay. Happy Holiday.

12 MR. MINORA: Thanks, and to you.

13 AGENT FLETCHER: Thank you.

14 (Whereupon, the above-entitled matter
15 was adjourned at 10:09 a.m.)
