ORDER DENYING THE PETITIONER'S REQUEST FOR REINSTATEMENT

On October 18, 2017, the Alcoholic Beverage Control Board (Board) issued Board Order No. 2017-511 cancelling John A Booker Jr., Inc., t/a Coast in Liquors (Petitioner), License No. ABRA-000014.

Specifically, on April 27, 2017, the ABRA's Licensing Division mailed a written notice to the Licensee notifying the Licensee that the safekeeping period for its license expired on September 30, 2017. The Licensee was further notified that if it wished to keep its license in Safekeeping, a written safekeeping extension request must be submitted to the Alcoholic Beverage Control Board (Board) at least ten (10) days before September 30, 2017, or the license will be cancelled, pursuant to the District of Columbia Official Code § 25-791(c). No such request was received by the Licensee.

On February 2, 2018, Clyde A. Prout sought reinstatement of the Retailer's Class A License No. ABRA-000014. The deadline for receipt of the Request for Reinstatement was November 1, 2017, ten (10) days from the date of Order No. 2017-511. However, the Petitioner's Request for Reinstatement was received by Alcoholic Beverage Regulation Administration (ABRA) on February 2, 2018; therefore, its request is considered untimely filed.


The Board finds that the Petitioner's Request for Reinstatement was untimely filed.

ORDER



Pursuant to D.C. Official Code § 25-433(d)(1), any party adversely affected may file a Motion for Reconsideration of this decision within ten (10) days of service of this Order with the Alcoholic Beverage Regulation Administration, 2000 14th Street, N.W., Suite 400S, Washington, DC 20009.

Also, pursuant to section 11 of the District of Columbia Administrative Procedure Act, Pub. L. 90-614, 82 Stat. 1209, D.C. Official Code §2-510 (2001), and Rule 15 of the District of Columbia Court of Appeals, any party adversely affected has the right to appeal this Order by filing a petition for review, within thirty (30) days of the date of service of this Order, with the District of Columbia Court of Appeals, 430 E Street, N.W., Washington, D.C. 20001; (202/879-1010). However, the timely filing of a Motion for Reconsideration pursuant to 23 DCMR §1719.1 (2008) stays the time for filing a petition for review in the District of Columbia Court of Appeals until the Board rules on the motion. See D.C. App. Rule 15(b) (2004).
