ORDER VACATING CANCELLATION OF LICENSE AND REINSTATING LICENSE

On November 18, 2020, the Alcoholic Beverage Control Board (Board) cancelled the Retailer Class CT License No. ABRA-107244 held by Brompton Group, LLC, t/a Columbus Club, because Brompton Group, LLC failed to pay the second year license fees. *See* Board Order No. 2020-826.

On December 3, 2020, Brompton Group, LLC (Petitioner), sought reinstatement of the Retailer's Class CT License No. ABRA-107244. In support of its request for reinstatement, the Petitioner indicated that all issues preventing the Petitioner from submitting its second year license fees have been resolved.

The Board finds that the reinstatement of the license is proper conditioned upon the requirement that the Petitioner pays the second year license fees.

Accordingly, it is this 9th day of December 2020, **ORDERED** that the **ORDER CANCELLING LICENSE** issued against the Petitioner, by the Board on November 18, 2020, be and hereby is **VACATED**.

IT IS FURTHER ORDERED that the Petitioner pay the required fees within two (2) weeks from the date of this Order.

However, the timely filing of a Motion for Reconsideration pursuant to 23 DCMR §1719.1 (2008) stays the time for filing a petition for review in the District of Columbia Court of Appeals until the Board rules on the motion.
