6	Hearing (Status) Calendar is Copycat Co., License

10	MS. SCHMIDT: Good morning. Amy
11	Schmidt, Assistant Attorney General on behalf of
12	the District of Columbia.
13	CHAIRPERSON ANDERSON: Good morning,
14	Ms. Schmidt.
15	MR. GONG: Yin Gong from Copycat.
16	CHAIRPERSON ANDERSON: Your last name,

17	not paid in 30 days, the license will be
18	suspended until the fine has been paid.
19	Is this your client's understanding of
20	the Offer in Compromise?
21	MR. MINORA: Yes, and we intend to pay
22	the fine this morning.

2	wonderful. Does your client is your client
3	aware that by accepting an Offer in Compromise,
4	that he is giving up his right to a hearing?
