22	CHAIRPERSON ANDERSON: Alright.				
23	Mr. Hines, it's my understanding that				
24	there is an offer in compromise. And the offer				
25	in compromise is a fine of \$2,000 paid within 90				

1 days. And if the fine is not paid within 90 2 3 days, the license will be suspended until the 4 fine has been paid. 5 Is this your understanding, sir, of the offer in compromise? 6 7 MR. HINES: Yes, it is. 8 CHAIRPERSON ANDERSON: Are you aware, sir, that by accepting an offer in compromise 9 10 that you are giving up the right to a hearing? 11 MR. HINES: Yes, I am. 12 CHAIRPERSON ANDERSON: Are you also 13 aware that by accepting an offer in compromise 14 that you're giving up your right to appeal this 15 matter? 16 MR. HINES: Yes, I am. 17 CHAIRPERSON ANDERSON: With that said, I then make a motion that the offer in compromise 18 19 of a fine of \$2,000 be paid within 90 days. If the fine is not paid within 90 20 21 days, the license will be suspended until the 22 fine has been paid. 23 Is there a second? 24 MEMBER SHORT: Mr. Short. I second. 25 CHAIRPERSON ANDERSON: Mr. Short has
