The Alcoholic Beverage Control Board met in the Alcoholic Beverage Control Hearing Room, Reeves Building, 2000 14th Street, N.W., Suite 400S, Washington, D.C. 20009, Chairperson Donovan W. Anderson, presiding.

8	MR. ORTIZ: Stephen Ortiz on behalf of
9	the District of Columbia.
10	CHAIRPERSON ANDERSON: Mr. Ortiz.
11	MR. DIETZ: Good morning. Bernard
12	Dietz on behalf of the licensee. I have with me
13	Mr. Ephraem Kassaye who is present and a DC
14	Market owner.
15	CHAIRPERSON ANDERSON: Good morning,
16	Mr. Dietz and Mr. Kassaye?
17	MR. KASSAYE: Yes.
18	CHAIRPERSON ANDERSON: There's a sign
19	in sheet so sign in, please. Parties please sign
20	in.
21	MR. DIETZ: All right.
22	CHAIRPERSON ANDERSON: All right.
23	We're off the record.
24	(Whereupon, the above-entitled matter
25	went off the record at 10:20 a.m. and resumed at

1 10:21 a.m.) 2 CHAIRPERSON ANDERSON: We're back on 3 the record. Mr. Ortiz, are there any preliminary 4 matters? This matter was scheduled for a show 5 cause hearing. Are we moving forward with our show 6 7 cause hearing or are there any preliminary 8 matters? 9 MR. ORTIZ: No. We have entered, the parties have entered into an offer in compromise. 10 11 As to Charge 1 --12 CHAIRPERSON ANDERSON: Let's get off 13 the record one more time before we go. 14 (Whereupon, the above-entitled matter 15 went off the record at 10:22 a.m. and resumed at 16 10:22 a.m.) 17 CHAIRPERSON ANDERSON: All right, I'm 18 We're back on the record. Go ahead. sorry. 19 MR. ORTIZ: As to Charge 1, the 20 establishment shall pay \$3,000 within 60 days or 21 his license shall be suspended indefinitely until 22 this fine is paid. 23 And the license shall be suspended for 24 five days with all five days stayed for one year. 25 Also, all employees who serve alcohol will take a

course within 90 days.

As to Charge 2, the establishment shall pay \$2,000 within 60 days or its license shall be suspended indefinitely until this fine is paid.

CHAIRPERSON ANDERSON: Mr. Dietz, it's my understanding that there is an offer in compromise. And the offer in compromise is that there is a fine, for Charge 1 there is a fine of \$3,000 payable in 60 days.

If the fine is not paid within 60 days the license will be suspended until the fine has been paid. Along with the \$3,000, also as part of Charge 1, there's a five day suspension.

All five days are stayed for one year pending their, provided that there are no further infractions within the next year. And all employees who sell or serve, who sell or serve alcohol will undergo a mandatory training within 90 days.

For Charge 2, there is a fine of \$2,000 payable within 60 days. If the fine is not paid within 60 days the license will be suspended until the fine has been paid.

Is this your client's understanding of

the offer in compromise?

MR. DIETZ: Yes, it is.

CHAIRPERSON ANDERSON: Is your client aware that by accepting an offer in compromise that they give up their right to a hearing?

MR. DIETZ: Yes.

CHAIRPERSON ANDERSON: And is your client also, are you and your client also aware that by accepting an offer in compromise that they're giving up their right to appeal this matter?

MR. DIETZ: Yes.

CHAIRPERSON ANDERSON: With that said,

I make a motion that the offer in compromise of a

fine for Charge 1, a fine of \$3,000 payable

within 60 days be accepted. If the fine is not

paid within 60 days the license will be

suspended.

Along with Charge 1, there is a five day suspension. All five days are stayed for one year provided that no further infractions are committed and that all employees who sell or serve alcohol will undergo mandatory training within the next 90 days.

For Charge 2, there is also a fine of

\$2,000 payable within 60 days. If the fine is 1 2 not paid within 60 days the license will be 3 suspended. Is there a second? 4 MEMBER SHORT: Second. 5 CHAIRPERSON ANDERSON: Mr. Short has 6 seconded the motion. All those in favor say aye. 7 (Chorus of aye) Those opposed. The matter passed 5-0-8 9 0. Thank you very much. The Board will issue a Board order in this matter.
