3 CHAIRPERSON ANDERSON: We now move on.

4 We return back to our Show Cause Hearing (Status)
5 Calendar. The next case on our calendar is Case
6 No. 18-CIT-00109, DCity Smokehouse, License No.
7 98368.

8 Will the parties, please, approach and
9 identify themselves for the record, please?

10 MR. RIVERO: Good morning, Board
11 Members. Fernando Rivero for the District of
12 Columbia.

13 CHAIRPERSON ANDERSON: Good morning,
14 Mr. Rivero.

15 MR. CREYKE: Good morning, Board
16 Members. John Creyke, Director of Operations for
17 Southeast Restaurant Group doing business as
18 DCity Smokehouse, representing Melvin Hines, the
19 owner. These are the letters that give Power of
20 Attorney for that.

21 CHAIRPERSON ANDERSON: Yes, you can
22 provide those to --

1 MR. CREYKE: Thank you, sir.

2 CHAIRPERSON ANDERSON: -- the Agency.
3 Thank you for bringing those.

4 MR. CREYKE: Thank you.

5 CHAIRPERSON ANDERSON: Are there any
6 preliminary matters in this case, Mr. Rivero?

7 MR. RIVERO: The parties do not have
8 an Offer in Compromise to present to the Board,
9 at this time. And we would move forward to the
10 next scheduled hearing.

11 CHAIRPERSON ANDERSON: Okay. Then
12 this matter then is scheduled for a Show Cause
13 Hearing on August 1st at 11:00 a.m.

14 MR. RIVERO: All right.

15 CHAIRPERSON ANDERSON: All right.
16 Thank you.

17 MR. RIVERO: If I could actually?

18 CHAIRPERSON ANDERSON: Yes, yes, Mr.
19 Rivero?

20 MR. RIVERO: It appears that I may
21 have a conflict on the 1st of August. I don't
22 know whether to work with the Board for another

1 date or file a motion and what have you.

2 CHAIRPERSON ANDERSON: I would say
3 work with the Board for the -- work with the
4 legal staff to reschedule it, but I just want to
5 let you know that we go on -- in August we meet
6 August 1st, August 8th and I think August 15th is
7 our last meeting until after Labor Day, so I
8 don't know what your schedule looks like for
9 August 8th or 15th, but if not, it would have to
10 be after Labor Day.

11 But again, work with Ms. Jenkins to
12 schedule that. Okay?

13 MR. RIVERO: Thank you.

14 CHAIRPERSON ANDERSON: Yes, sir?

15 MR. CREYKE: DCity Smokehouse are more
16 than happy to accommodate Mr. Rivero for any
17 schedule changes he needs for his own personal
18 needs.

19 CHAIRPERSON ANDERSON: Thank you for
20 making that offer. Thank you, sir.

21 MR. CREYKE: Thank you.

22 CHAIRPERSON ANDERSON: All right.

1 MR. RIVERO: It's actually another
2 work conflict. Thanks.

3 MR. CREYKE: Thank you.

4 CHAIRPERSON ANDERSON: All right. So
5 I think Mr. Rivero will contact the Agency and
6 contact you to let you know what date to see if
7 that works and we will move forward. All right.

10 right. Okay. That's it, sir. Thank you.
