3 MS. FLETCHER: Would the parties in  
4 the matter of Dangerously Delicious please come  
5 forward? The parties in the matter of  
6 Dangerously Delicious.

7 This is case number 19-PRO-00025, 1339  
8 H Street, NE, License number ABRA-087422. This  
9 is the retailer class CR license renewal. The  
10 protest issues are adverse impact on peace, order  
11 and quiet.

12 My name is LaVerne Fletcher conducting  
13 the Roll Call Hearing as the Board's Agent.  
14 Introductions, beginning with the applicant,  
15 please.

16 MS. YOHANNES: Sidon Yohannes on  
17 behalf of the applicant.

18 MS. FLETCHER: And your name, ma'am?

19 MS. BASANTI: My name is Sandra  
20 Basanti.

21 MS. FLETCHER: Could you state that  
22 one more time and spell it for the record,

1 please?

2 MS. BASANTI: Sandra, S-A-N-D-R-A,  
3 last name Basanti, B-A-S-A-N-TI.

4 MS. FLETCHER: Ms. Yohannes, would you  
5 spell your name for the record as well?

6 MS. YOHANNES: Sure. S-I-D-O-N, Y-O-  
7 H-A-N-N-E-S.

8 MS. FLETCHER: And on behalf of ANC6A?

9 MR. WILLIAMS: Good morning, Ms.  
10 Fletcher. It's Jay Williams on behalf of ANC6A.  
11 And Williams with an S.

12 MS. FLETCHER: Thank you, Mr.  
13 Williams. ANC6A has standing as a protestant.  
14 We need to set a date for a mediation, a status  
15 hearing and a protest hearing. I'll give you the  
16 date for the status and protest hearing first.

17 The status hearing is set for June  
18 26th, at 9:30. That's June 26th, at 9:30 for the  
19 status hearing. The protest hearing is set for  
20 July 31. July 31, at 1:30 p.m., for the protest  
21 hearing. We need to set a date for mediation.

22 I'll give you the next available day.

1 The next available day for mediation is June 6th,  
2 that's a Thursday, at 9:00, 10:00, 11:00, 1:00 or  
3 2:00. That's June 6th.

4 (Off microphone comments.)

5 MR. WILLIAMS: I could do 10:00 that,  
6 10:00 a.m. that day. I have conflicts the other  
7 times. I don't know what works for you all?

8 MS. YOHANNES: Calendar. Sorry. One  
9 moment.

10 MS. FLETCHER: Okay.

11 MS. YOHANNES: 10:00 a.m.?

12 MS. FLETCHER: 10:00 a.m.

13 MR. WILLIAMS: That works.

14 MS. YOHANNES: And June 6th, 10:00  
15 a.m. is fine, but preliminarily, I just want to  
16 make some notations on this protest letter.

17 MS. FLETCHER: Yes.

18 MS. YOHANNES: I do want the ANC to  
19 indicate a seven days -- a seven-day notice was  
20 sent to the applicant.

21 I don't believe the applicant received  
22 notice of the ANC meeting and I don't believe

1 that this protest letter states that they did.

2 MS. FLETCHER: That is required for  
3 the citizens association only. Is not required  
4 for the ANC.

5 MR. WILLIAMS: And I'll also note that  
6 all of our agendas are posted at least seven days  
7 in advance, publicly on various listservs and on  
8 the website, but I also agree that it's only  
9 required for citizen associations.

10 MS. YOHANNES: And also, as a  
11 designation, I believe that this letter says that  
12 they -- it was given, but was --

13 -- was there a designation of the  
14 committee that signed for the protest letter,  
15 because it was signed by a committee member and  
16 not an ANC member.

17 MS. FLETCHER: For ABRA that's fine.

18 MR. WILLIAMS: And ANC also --

19 MS. YOHANNES: Okay.

20 MR. WILLIAMS: -- voted to authorize  
21 me as the co-chair of the committee as well as  
22 the other co-chair and two other commissioners to

1 represent and that was part of the vote that the  
2 full ANC took.

3 MS. FLETCHER: Thank you. Anything  
4 else for the record, Ms. Yohannes?

5 MS. YOHANNES: That's all.

6 MS. FLETCHER: Okay. Thank you. A  
7 mediation is set for June 6th at 10:00 o'clock,  
8 a.m. Anything else?

9 MS. YOHANNES: That's all for the  
10 applicant.

11 MS. FLETCHER: Okay.

12 MR. WILLIAMS: Nothing for the ANC.

13 MS. FLETCHER: The roll call hearing  
14 is concluded. Thank you for coming.

15 MS. YOHANNES: Thank you.

16 MR. WILLIAMS: Thank you.
